Extracts from Laws Relating to the Listing of Personal Property.

(Section Numbers Refer to Minnesota Statutes 1941)

Sec. 272.01. PROPERTY SUBJECT TO TAXATION. All real and personal property in this state, and all personal property of persons residing therein, is taxable, except such as is by law exempt from taxation.

WHEN LISTED AND ASSESSED

Sec. 273.01. Personal property shall be listed and assessed annually with reference to its value on May 1, and if acquired on that day, shall be listed by or for the persons acquiring it.

Sec. 273.22. By whom listed. Personal property shall be listed in the manner following: 1. Every person of full age and sound mind, being a resident of this state, shall list all of his personal property...

Sec. 273.23. Certain real property. Sec. 273.24. Manufacturers, etc., on railroad. All elevators and sawmills, and other manufacturing establishments, situated upon the land of any railroad company which is not operated and exclusively controlled by such company, shall be listed and assessed as personal property in the town or district where situated.

Sec. 273.25. Merchants and manufacturers. The personal property of a merchant or manufacturer, where the business is carried on in the town or district, shall be listed and assessed in the town or district where the business is carried on.

Sec. 273.26. Farm property of non-resident. When the owner of real estate in this state is a non-resident, the personal property of such owner, situated on the land of such real estate, shall be listed and assessed in the town or district in which the principal place of business of such farm is located.

Sec. 273.27. Personal property of electric light and power companies outside of cities and villages. Personal property, where listed, all electric light and power companies, shall be listed and assessed in the town or district where the principal place of business of such company is located.
