Extracts from Laws Relating to the Listing of Personal Property.

(Section Numbers Refer to Minnesota Statutes 1941 as Amended by Laws 1945)

Sec. 272.01. PROPERTY SUBJECT TO TAXATION. All real and personal property in this state, and all personal property of persons residing therein, * * * is taxable, except such as is by law exempt from taxation.

WHEN LISTED AND ASSESSED

Sec. 272.01. * * * Personal property shall be listed and assessed annually with reference to its value on May 1, and if acquired on that day, shall be listed by or for the persons acquiring it.

The personal property belonging to the business of a merchant or of a manufacturer, or of a corporation whose assets are in the hands and control of such person or corporation, shall be listed and assessed in the same manner as other personal property in the district where the same is usually kept.

Sec. 272.26. Where listed. Except as otherwise in this chapter provided, the personal property of a person shall be listed in the town or district where owned, sold, or stored, or in the town or district where the same is usually kept.

Birch Lake, Cass

Section 272.03. Minnesota Statutes 1941. Assessment; Mode. The county auditor shall annually provide the necessary assessment books and blanks at the expense of the county, for and to correspond with each assessment district. He shall make it his duty to prepare an assessment book, complete lists of all lands or lots subject to taxation, showing the nature and location of the same, and the names of the owners thereof, and a list of all personal property becoming subject to assessment and taxation every odd numbered year may be appended to the personal property assessment book. The assessment books and blanks shall be in readiness for delivery to the assessors on or before the third Monday in APRIL of each year.

The assessors shall meet at the office of the county auditor on a day to be fixed by the Commissioner of Taxation for the purpose of receiving instructions as to their duties under the laws of the state. Each assessor attending such meetings shall receive mileage at the rate of five cents per mile for each mile necessarily traveled in going from his home to the place of meeting, and returning from the county seat, to be computed by the usually traveled route, and paid out of the county treasury upon the warrant of the county auditor.
