Extracts from Laws Relating to the Listing of Personal Property.

(Section Numbers Refer to Minnesota Statutes 1945)

Sec. 272.01. **PROPERTY SUBJECT TO TAXATION.** All real and personal property in this state, and all personal property of persons residing therein, *** is taxable, except such as is by law exempt from taxation.

WHEN LISTED AND ASSESSED

Sec. 273.01. *** Personal Property shall be listed and assessed annually with reference to its value on May 1 of each year. If acquired on that day, shall be listed by or for the persons acquiring it.

Sec. 273.02. *** Personal Property shall be listed in the manner following:

1. Every person of full age and sound mind, being a resident of this state, shall list all of his *** personal property, *** the principal place of business of which he is the owner, and all income and other personal property in which he is interested, controlled by him as agent or attorney, ***.
2. The property of a minor, child or insane person shall be listed by the trustee, or the person for whose benefit it is held in trust, by the trustee; of the estate of a deceased person, by the executor or administrator.
3. The property of a corporation whose assets are in the hands of a stockholder, partner, officer or director, shall be listed and assessed in the name of such stockholder, partner, officer or director.
4. The property of a firm or company, by a partner or agent thereof.
5. The property of a body politic or corporate, by the proper agent or officer thereof.
6. The property of manufacturers and others in the hands of an agent, by such agent in the name of his principal, as merchandise.

Sec. 273.26. Where listed. Except as otherwise in this chapter provided, personal property shall be listed and assessed in the county, town or district in which the principal place of business of the owner is located. ***

Sec. 273.27. Personal property. *** household goods and furniture, including clocks, musical instruments, sewing machines, wearing apparel of members of the family, and other personal property, shall be listed and assessed in the county, town or district in which the principal place of business of the owner is located. ***

Sec. 273.28. *** Personal property. *** The personal property pertaining to the business of a district where his business is carried on ***.

Sec. 273.30. Farm property. *** The personal property of a non-resident, when the owner of the property is a resident of this state, shall be listed and assessed in the county, town or district where the farm is situated. If the farm is situated in one town or district, it shall be listed and assessed in that town or district. If the principal place of business of the owner is located in another town or district, it shall be listed and assessed in that town or district.

Sec. 273.32. Elevators, etc., on railroad. *** All elevators and other structures, including the machinery, and all other structures operated and exclusively controlled by such company, shall be listed and assessed as personal property in the town or district where the principal place of business of the owner is located. ***

Sec. 273.33. Pipeline Companies, Subdivision 1. Personal property. *** The personal property pertaining to the business of a district where the business is carried on ***.

Sec. 273.34. *** Personal property. *** The personal property of a corporation, partnership, firm or company, shall be listed and assessed in the county, town or district where the principal place of business of the owner is located. ***

Sec. 273.35. Gas and Water Companies. The personal property of a gas or water company, including the machinery, and all other structures operated and exclusively controlled by such company, shall be listed and assessed as personal property in the town or district where the principal place of business of the owner is located. ***

Sec. 273.36. Electric Light and Power Companies to be listed and assessed. *** The personal property of an electric light and power company, including the machinery, and all other structures operated and exclusively controlled by such company, shall be listed and assessed as personal property in the town or district where the principal place of business of the owner is located. ***
