OFFICE OF COUNTY AUDITOR, County, Minn., 1948.

Assessor of the ... According to the requirements of law, I herewith deliver to you the Real and Personal Property Assessment Books for the year 1948, containing a list of all Real Estate subject to taxation, so far as the same have come to my knowledge from any source, and I hereby direct you to assess all Property and make return thereof to me as required by the laws of the State of Minnesota prescribing the duties of the assessor. A form of the return to be signed by you is appended in this book.

Extracts from Laws Relating to the Listing of Personal Property.

(Section Numbers Refer to Minnesota Statutes 1945)

WHEN LISTED AND ASSESSED

Sec. 273.01. PROPERTY SUBJECT TO TAXATION. All real and personal property, and all personal property of persons residing therein, is taxable, except such as is by law exempt from taxation.

Sec. 273.02. Personal property shall be listed and assessed annually with reference to its value on May 1, and if acquired on that day, shall be listed by or for the persons acquiring it.

Sec. 273.03. Personal property shall be listed in this state, shall list all of his personal property.

Sec. 273.04. Personal property shall be listed by his guardian or by the person having such property in charge.

Sec. 273.05. Personal property shall be listed by the executor or administrator.
