A form of the return to be signed by you is appended in this book.

Extracts from Laws Relating to the Listing of Personal Property

Section Numbers refer to Minnesota Statutes

Sec. 272.01. PROPERTY SUBJECT TO TAXATION. All real and personal property in this state, and all personal effects residing therein, ... is taxable, except such as is by law exempt from taxation.

WHEN LISTED AND ASSESSED. Sec. 273.01. Personal Property shall be listed and assessed annually with reference to its value on May 1st of each year, and shall be listed by or for the persons acquiring it.

Sec. 273.02. Personal Property shall be listed in the manner following: 1. Every person of full age and sound mind, being a resident of this state, shall list the real and personal property owned by him, and all real and personal property inherited, loaned, or otherwise acquired by him, and all real and personal property owned by his guardian, child, or insane person, and all real and personal property owned by the person having such property in charge, and all real and personal property owned by the administrator of an estate, and all real and personal property owned by a corporation whose assets are in the hands of a receiver, by such receiver.

Sec. 273.03. The property of a firm or company, by a partner or agent thereof, the property of a partnership, by a partner or agent thereof, the property of a trust, by a trustee, and the property of a decedent, by an executor, administrator, or guardian, shall be listed in the manner following: 1. The property of a firm or company, by a partner or agent thereof, shall be listed in the name of the principal as mentioned in this section, and assessed in the county, town, or district where the firm or company is located.

Sec. 273.04. Certain personal property, where listed, all household and furniture, including clocks, musical instruments, sewing machines, and other personal property, shall be listed in the county, town, or district where the same is usually kept.

Sec. 273.05. Merchants and manufacturers. The personal property of a merchant or manufacturer shall be listed in the county, town, or district where the business is conducted, and assessed in the county, town, or district where the same is usually kept.

Sec. 273.06. Farm property of non-resident. When the owner of real and personal property situated on a farm does not reside therein, the same shall be listed and assessed in the county, town, or district where the farm is situated, in several townships or districts in the principal place of business of such farm is located.

Sec. 273.07. Electric Light and Power Companies and others. The personal property of an electric light and power company, or other person or corporation, shall be listed in the county, town, or district where the same is usually kept.

Sec. 273.08. Electric Light and Power Companies and others. The personal property of an electric light and power company, or other person or corporation, shall be listed in the county, town, or district where the same is usually kept.

Sec. 273.09. Merchants, Craftsmen, Every merchant, required to list his property, shall list the same in the county, town, or district where the same is usually kept.

Sec. 273.24. Manufacturers. Every manufacturer required to list his property, shall list the same in the county, town, or district where the business is conducted, and assessed in the county, town, or district where the same is usually kept.

Sec. 273.25. Assignees and receivers. Personal property in the hands of an assignee or receiver shall be listed and assessed in the county, town, or district where the same is usually kept.

Sec. 273.26. Personal property of a decedent. The personal property of a decedent shall be listed and assessed in the county, town, or district where the same is usually kept.

Sec. 273.27. Personal property of a firm or company. The personal property of a firm or company shall be listed and assessed in the county, town, or district where the same is usually kept.

Sec. 273.28. Personal property of a partnership. The personal property of a partnership shall be listed and assessed in the county, town, or district where the same is usually kept.

Sec. 273.29. Personal property of a trust. The personal property of a trust shall be listed and assessed in the county, town, or district where the same is usually kept.

Sec. 273.30. Personal property of a decedent. The personal property of a decedent shall be listed and assessed in the county, town, or district where the same is usually kept.

Sec. 273.31. Personal property of a firm or company. The personal property of a firm or company shall be listed and assessed in the county, town, or district where the same is usually kept.

Sec. 273.32. Personal property of a partnership. The personal property of a partnership shall be listed and assessed in the county, town, or district where the same is usually kept.

Sec. 273.33. Personal property of a trust. The personal property of a trust shall be listed and assessed in the county, town, or district where the same is usually kept.

Sec. 273.34. Personal property of a decedent. The personal property of a decedent shall be listed and assessed in the county, town, or district where the same is usually kept.

Sec. 273.35. Personal property of a firm or company. The personal property of a firm or company shall be listed and assessed in the county, town, or district where the same is usually kept.

The forms in this book are prescribed for the 1965 assessment by The Commissioner of Taxation

Minnesota Statutes, Section 270.07. The commissioner of taxation shall prescribe the form of all blanks and books required under this chapter ... Minnesota Statutes, Section 273.03. The county auditor shall annually provide the necessary assessment books and blanks at the expense of the county, for and to correspond with each assessment district. He shall make out, in the real property assessment book, complete lists of all lands or lots subject to taxation, showing the names of the owners, if to him known; and, if unknown, so stated opposite each tract or lot, the number of acres, and the lots or parts of lots or blocks included in each description of property...

Minnesota Statutes, Section 273.04. The assessors and at least one member of each local board of review shall meet at the office of the county auditor on a day to be fixed by the commissioner of taxation for the purpose of receiving instructions as to their duties under the laws of the state. Each assessor attending such meetings shall receive, as compensation for such service the sum of \$1.50 per day for each day necessary attending such meetings, and mileage at the rate of five cents per mile, and each board of review member the sum of \$6.00 per day and mileage at the rate of five cents per mile for each mile necessarily traveled in going from his home to and returning from the county seat, to be computed by the usually traveled route, and paid out of the county treasury upon the warrant of the county auditor.
