Extracts from Laws Relating to the Listing of Personal Property.

(Section Numbers Refer to Minnesota Statutes 1943 as Amended by Laws 1945)

Sec. 272.01. PROPERTY SUBJECT TO TAXATION. All real and personal property in this state, and all personal property of person, residing therein, \*\*\* is taxable, except such as is by law exempt from taxation.

WHEN LISTED AND ASSESSED

Sec. 273.01. Personal Property shall be listed and assessed annually with reference to May 1, and if acquired on that day, shall be listed by or for the persons acquiring it.

Sec. 273.22. By whom listed. Personal Property shall be listed in the manner following:  
1. The property of a decedent, being a resident of this state, shall list all of his \*\*\* personal property, in and to the extent of his interest therein, in the county, town, or district where owner, agent or trustee resides.

Sec. 273.23. Certain personal property, where listed. All motor vehicles, sewing machines, wearing apparel of members of the family, and all personal property used by the owner for personal and domestic purposes, shall be listed and assessed in the county, town, or district where the owner usually kept.

Sec. 273.24. Manufacturers, Every manufacturer required to list his property shall also list the value of his property pertaining to his business, in the county, town, or district where he is located, and assessed in the county, town, or district where situated.

Sec. 273.25. Merchants. Every merchant required to list his property shall also list the value of his property pertaining to his business, in the county, town, or district where he is located, and assessed in the county, town, or district where situated.

Sec. 273.26. Manufacturers, Every manufacturer required to list his property shall also list the value of his property pertaining to his business, in the county, town, or district where he is located, and assessed in the county, town, or district where situated.

Sec. 273.27. Personal property of electric light and power companies in cities and villages. Personal property of electric light and power companies shall be listed and assessed in the county, town, or district where situated.

Sec. 273.28. Personal property of non-resident. When the owner of personal property is a non-resident, the property shall be listed and assessed in the county, town, or district where the property is situated.

Section 273.03. Minnesota Statutes 1941. Assessment. Made. The county auditor shall annually provide the necessary assessment books and blanks at the expense of the county, for and to correspond with each assessment district. He shall make out, in the real property assessment book, complete lists of all lands or lots subject to taxation, showing the names of the owners of the land, the acreage of the land, the number of acres, and the lots or parts of lots or blocks, included in each assessment district, and shall file a copy of such lists with the county auditor on or before the third Monday in April.

The assessors shall meet at the office of the county auditor on a day to be fixed by the Commissioner of Taxation for the purpose of receiving instructions as to their duties under the law. Each assessor attending such meetings shall receive as compensation for such service the sum of four dollars per day for each day for each assessor, and mileage at the rate of five cents per mile for each mile necessarily traveled in going from his home to the office, and in returning from the county seat, to be computed by the usually traveled route, and paid out of the county treasury upon the warrant of the county auditor.

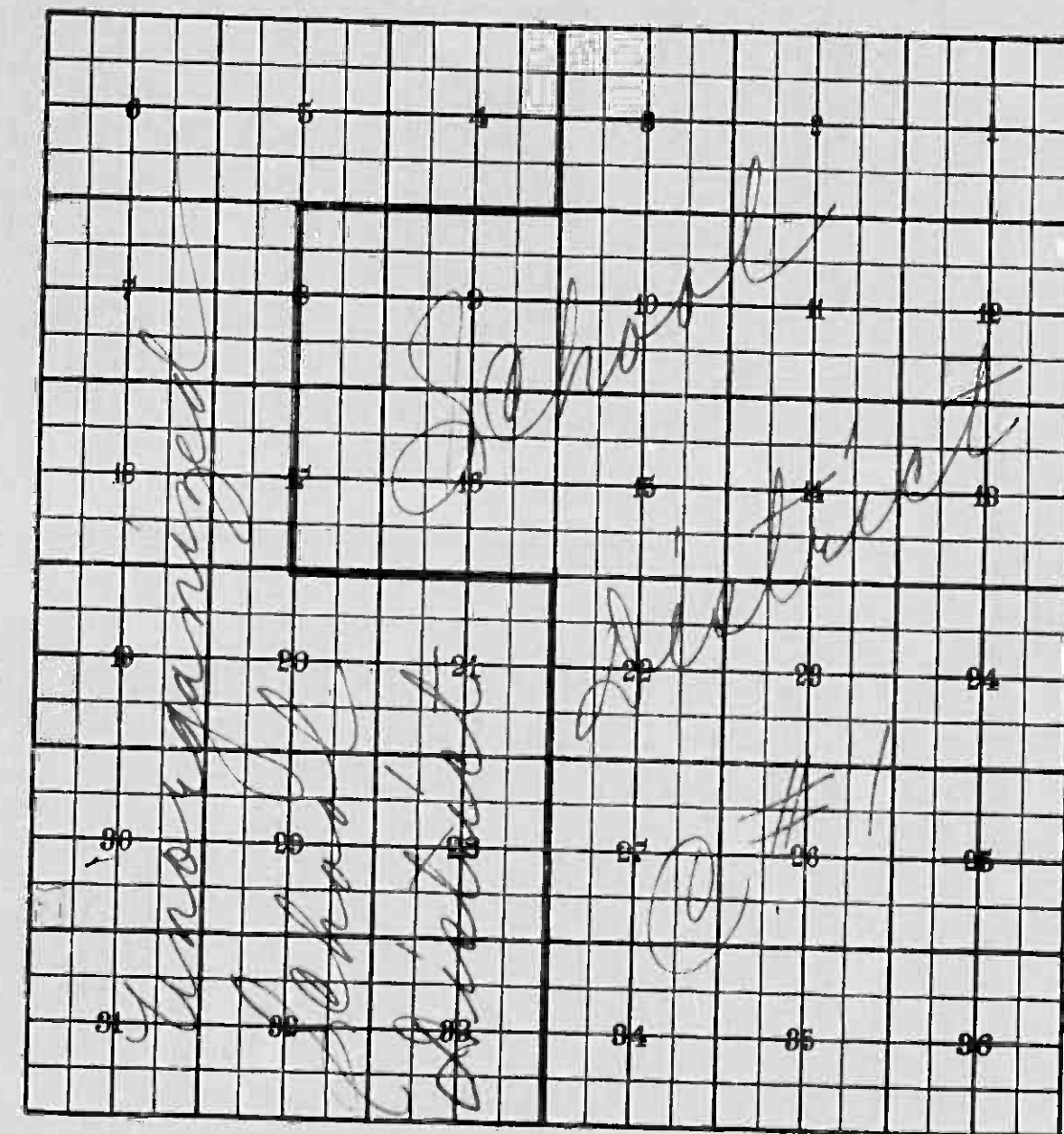
