To, Assessor of the County, Minn.,

According to the requirements of law, I herewith deliver to you the Assessment Books for the year 1965, as the same has come to my knowledge from any source, and I hereby direct you to assess such Real Estate and all Personal Property, and make such changes in Real Estate as are required in the old-numbered year, and make a form of the return to be signed by you as appended in this book.

Extracts from Laws Relating to the Listing of Personal Property Section Numbers refer to Minnesota Statutes

Sec. 272.01. PROPERTY SUBJECT TO TAXATION. All real and personal property in this state, and all personal property of persons residing in this state, is taxable, except such as is by law exempt from taxation.

WHEN LISTED AND ASSESSED Sec. 273.01. Personal Property shall be listed and assessed annually on the 1st day of May, and if acquired on that day, shall be listed by or for the persons acquiring it.

7. The property of a firm or company, by a partner or agent thereof, by such agent in the name of his principal, as merchant, in town, or district where owned, shall be listed and assessed in the district where the same is usually kept.
