Extracts from Laws, Relating to the Listing of Personal Property. (Section Numbers refer to Mason's Minnesota Statutes of 1927)

Sec. 1974. Property subject to taxation. All real and personal property in this state, including the interest therein, shall be assessed and taxed in such manner as is provided in this chapter.

Sec. 1975. When listed and assessed. The assessor shall list and assess the property in the manner following: When listed. Personal property shall be listed in the manner following: (1) All real estate, including land, buildings, and other improvements thereon, shall be listed in the name of the owner or the person in whose name the title to the property is held. (2) All personal property, including stocks, bonds, and other securities, shall be listed in the name of the owner or the person in whose name the title to the property is held. (3) All personal property, including household goods and furniture, shall be listed in the name of the owner or the person in whose name the title to the property is held. (4) All personal property, including automobiles, trucks, and other motor vehicles, shall be listed in the name of the owner or the person in whose name the title to the property is held.
