

PROPOSED LEGAL DESCRIPTIONS

That part of the Southwest Quarter of the Northwest Quarter, Section 1, Township 141 North, Range 26 West, Cass County,

COMMENCING at the intersection of the southwesterly line of Block 2, SOO ADDITION TO REMER, according to the recorded plat thereof, said County, also being the southwesterly right—of—way line of the Soo Line Railroad, with the easterly right—of—way line of Park Avenue; thence South 01 degree 35 minutes 35 seconds East, assumed bearing, along said easterly right—of—way line of Park Avenue, 409.00 feet; thence South 89 degrees 36 minutes 16 seconds West, parallel to the north line of said Section 1 a distance of 32.93 feet to the west line of said Southwest Quarter of the Northwest Quarter, the point of beginning of the tract to be herein described; thence North 89 degrees 36 minutes 16 seconds East, parallel to said north line 445.92 feet to said southwesterly line of Block 2; thence South 01 degree 35 minutes 35 seconds East 662.13 feet to the south line of said Southwest Quarter of the Northwest Quarter; thence South 89 degrees 10 minutes 32 seconds West along said south line 445.87 feet to the southwest corner of said Southwest Quarter of the Northwest Quarter; thence North 01 degree 35 minutes 35 seconds West along said west line of the Southwest Quarter of the Northwest Quarter 665.47 feet to the point of beginning.

COMMENCING at the intersection of the southwesterly line of Block 2, SOO ADDITION TO REMER, according to the recorded plat thereof, said County, also being the southwesterly right—of—way line of the Soo Line Railroad, with the easterly right—of—way line of Park Avenue; thence South 01 degree 35 minutes 35 seconds East, assumed bearing, along said easterly right—of—way line of Park Avenue, 409.00 feet; thence North 89 degrees 36 minutes 16 seconds East, parallel to the north line of said Section 1 a distance of 412.99 feet to said southwesterly line of Block 2; thence South 46 degrees 16 minutes 01 second East along said southwesterly line of Block 2 a distance of 353.01 feet to the point of beginning of the tract to be herein described; thence North 46 degrees 16 minutes 01 second West along said southwesterly line of Block 2 a distance of 353.01 feet; thence South 01 degrees 35 minutes 35 seconds East 662.13 feet to the south line of said Southwest Quarter of the Northwest Quarter; thence North 89 degrees 10 minutes 32 seconds East along said south line 238.59 feet to the intersection with a line bearing South 00 degrees 15 minutes 46 seconds East from the point of beginning; thence North 00 degrees 15 minutes 46 seconds West 414.41 feet to the point of beginning.

That part of the Southwest Quarter of the Northwest Quarter, Section 1, Township 141 North, Range 26 West, Cass County,

COMMENCING at the intersection of the southwesterly line of Block 2, SOO ADDITION TO REMER, according to the recorded plat thereof, said County, also being the southwesterly right-of-way line of the Soo Line Railroad, with the easterly right-of-way line of Park Avenue; thence South 01 degree 35 minutes 35 seconds East, assumed bearing, along said easterly right-of-way line of Park Avenue, 409.00 feet; thence North 89 degrees 36 minutes 16 seconds East, parallel to the north line of said Section 1 a distance of 412.99 feet to said southwesterly line of Block 2; thence South 46 degrees 16 minutes 01 seconds East along said southwesterly line of Block 2 a distance of 353.01 feet to the point of beginning of the tract to be herein described; thence South 00 degrees 15 minutes 46 seconds East 414.41 feet to the south line of said Southwest Quarter of the Northwest Quarter; thence North 89 degrees 10 minutes 32 seconds East along said south line 424.90 feet to the intersection with the southeasterly extension of said southwesterly line of Block 2; thence North 46 degrees 16 minutes 01 second West along said southeasterly extension and along said southwesterly line of Block 2 a distance of 590.61 feet to the point of beginning. LESS that part of the Southwest Quarter of the Northwest Quarter of Section 1, Township 141 North, Range 26 West lying


between the intersection of the right—of—way—of—way of the Soo Line Railroad and the right—of—way of the State Highways No. 6 and No. 34, forming a triangle with a 120 foot front on the right—of—way of the State Highways No. 6 and No. 34, with a 166.80 foot side on the right-of-way line of the Soo Railroad and the west side of the triangle being 115.90 feet.
