LAND DESCRIPTION FOR THE MEYER TRACT LOCATED IN BIRCH LAKE TOWNSHIP
OF CASS COUNTY, MINNESOTA

That part of Government Lot 4, Section 34, Township 140 North, Range
30 West of the 5th Principal Meridian, described as follows:

Commencing at the southwest corner of said Government Lot 4; thence South 87 degrees 32 minutes 27 seconds East 1071.35 feet, initial bearing assigned, along the south line of said Government Lot 4; thence North 2 degrees 23 minutes 00 seconds East 1502.34 feet to the point of BEGINNING of the land to be described; thence North 79 degrees 48 minutes 15 seconds East 140.10 feet; thence North 8 degrees 07 minutes 11 seconds West 201.53 feet; thence North 25 degrees 50 minutes 40 seconds East 67.00 feet; thence North 3 degrees 38 minutes 34 seconds East 87 feet, more or less, to the water's edge of Pleasant Lake; thence southwesterly along said water's edge of Pleasant Lake to the line that bears North 2 degrees 23 minutes 00 seconds East from the point of beginning; thence South 2 degrees 23 minutes 00 seconds West 303 feet, more or less, to the point of beginning.

Containing 33,600 square feet of area, more or less.

Together with and subject to a 33.00 foot wide Roadway and Utility Easement, over, under and across the following described property:

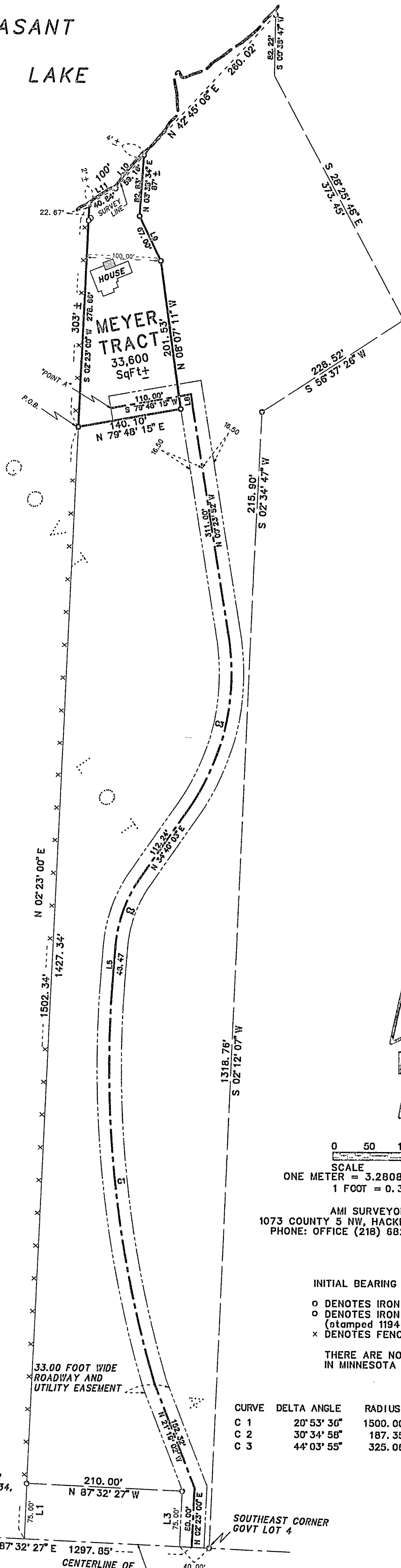
Part of said Government Lot 4.

The centerline of said 33.00 foot wide Roadway and Utility Easement is described as follows:

Commencing at the southwest corner of said Government Lot 4; thence South 87 degrees 32 minutes 27 seconds East 1297.85 feet along the south line of said Government Lot 4 to the point of beginning of the centerline to be described; thence North 2 degrees 23 minutes 00 seconds East 80.00 feet along said centerline; thence North 21 degrees 19 minutes 02 seconds West 152.32 feet along said centerline; thence northerly 546.99 feet along a non-tangential curve to the right, having a central angle of 20 degrees 53 minutes 36 seconds, a radius of 1500.00 feet and the chord of said curve bears North 6 degrees 21 minutes 43 seconds West for a distance of 543.96 feet; thence North 4 degrees 05 minutes 05 seconds East 46.47 feet, tangent to said curve; thence northerly 100.00 feet along a tangential curve to the right, having a central angle of 30 degrees 34 minutes 58 seconds East and a radius of 187.35 feet; thence North 34 degrees 40 minutes 03 seconds East 112.24 feet, tangent to the last described curve; thence northerly 250.00 feet along a tangential curve to the left, having a central angle of 44 degrees 03 minutes 55 seconds and a radius of 325.06 feet; thence North 9 degrees 23 minutes 52 seconds West 311.00 feet, tangent to the last described curve; thence North 8 degrees 07 minutes 11 seconds West 16.50 feet; thence South 79 degrees 48 minutes 15 seconds West 110.00 feet to a point hereinafter referred to as "Point A", and said centerline there ending.

The sidelines of said 33.00 foot wide Roadway and Utility Easement are to be prolonged or shortened to terminate on the northerly Right of Way line of C.S.A.H. #45 and on the line that bears North 10 degrees 11 minutes 45 seconds East from said "Point A".

Subject to easements, reservations, conditions and restrictions, if any.

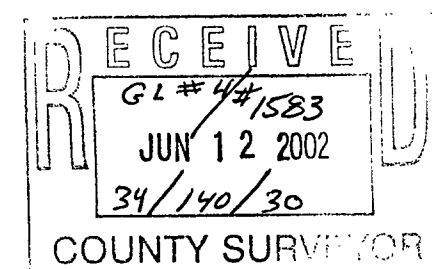
