AND commencing at the Southeast corner of said North Half of the North Half of the Northwest Quarter of the Southwest Quarter; thence North 0 degrees 05 minutes 16 seconds East, assumed bearing along the East line thereof 182.17 feet; thence North 89 degrees 54 minutes 44 seconds West 350.00 feet; thence South 0 degrees 05 minutes 16 seconds West 17.84 feet to the point of beginning of the tract to be herein described; thence North 89 degrees 54 minutes 44 seconds West 232.37 feet, more or less, to the intersection with a line bearing North from said Point "A"; thence on a bearing of North 345 feet, more or less, to the shoreline of Leech Lake; thence easterly along said shoreline to the intersection with a line bearing North 0 degrees 05 minutes 16 seconds East from the point of beginning; thence South 0 degrees 05 minutes 16 seconds West 343 feet, more or less, to the


Half of the North Half of the Northwest Quarter of the Southwest Quarter and the North Half of the North Half of the Northwest Quarter of the Southwest Quarter, said Section 36, the centerline of which is described as follows: Commencing at the Southwest corner of said North Half of the South Half of the North Half of the Northwest Quarter of the Southwest Quarter; thence North 0 degrees 02 minutes 55 seconds West, assumed bearing along the West line thereof 16.50 feet to the point of beginning of the centerline to be herein described; thence South 89 degrees 24 minutes 00 seconds East 772.78 feet; thence North 82 degrees 27 minutes 15 seconds East 175.57 feet; thence northeasterly 109.69 feet along a tangential curve concave to the northwest, having a radius of 100.00 feet and a central angle of 62 degrees 50 minutes 53 seconds; thence North 19 degrees 36 minutes 21 seconds East, tangent to said curve 122.93 feet; thence northwesterly 139.81 feet along a tangential curve concave to the southwest, having a radius of 90.00 feet and a central angle of 89 degrees 00 minutes 29 seconds; thence North 69 degrees 24 minutes 08 seconds West, tangent to last said curve 48.55 feet and said centerline there terminating.

Together with an easement for ingress and egress 33.00 feet in width over and across the North Half of the South
