The Northwest Quarter of the Southeast Quarter of Section 14. Township 133 North. Range 31 West. Cass County. Minnesota.

Commencing at the southwest corner of said Northwest Quarter of the Southeast Quarter: thence South 88 degrees 53 minutes 01 seconds East. bearings are based on the North American Datum of 1983. along the south line of said Northwest Quarter of the Southeast Quarter a distance of 469.67 feet to the west line of the East 863.52 feet of said Northwest Quarter of the Southeast Quarter which is the point of beginning of the tract to be described: thence North 00 degrees 11 minutes 07 seconds West along said west line. a distance of 208.41 feet to the north line of the South 208.36 feet of said Northwest Quarter of the Southeast Quarter: thence South 88 degrees 53 minutes 01 seconds East along said north line. a distance of 673.63 feet: thence South 35 degrees 25 minutes 33 seconds East. a distance of 63.14 feet: thence South 14 degrees 30 minutes 51 seconds East, a distance of 124.95 feet: thence South 01 degrees 00 minutes 50 seconds East, a distance of 128.84 feet to the south line of the North 91.46 feet of said Southwest Quarter of the Southeast Quarter: thence North 88 degrees 53 minutes 01 seconds West along said south line, a distance of 742.87 feet to the west line of the East 863.52 feet of said Southwest Quarter of the Southeast Quarter: thence North 00 degrees 11 minutes 07 seconds West along said west line. a distance of 91.48 feet to the point of beginning.


