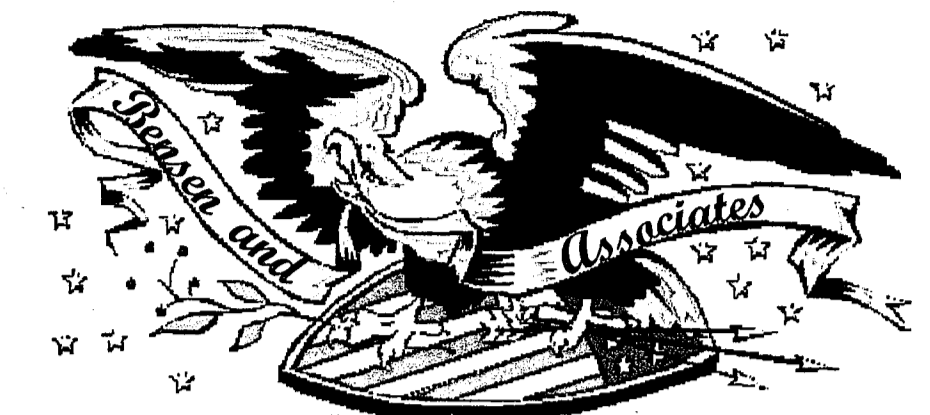
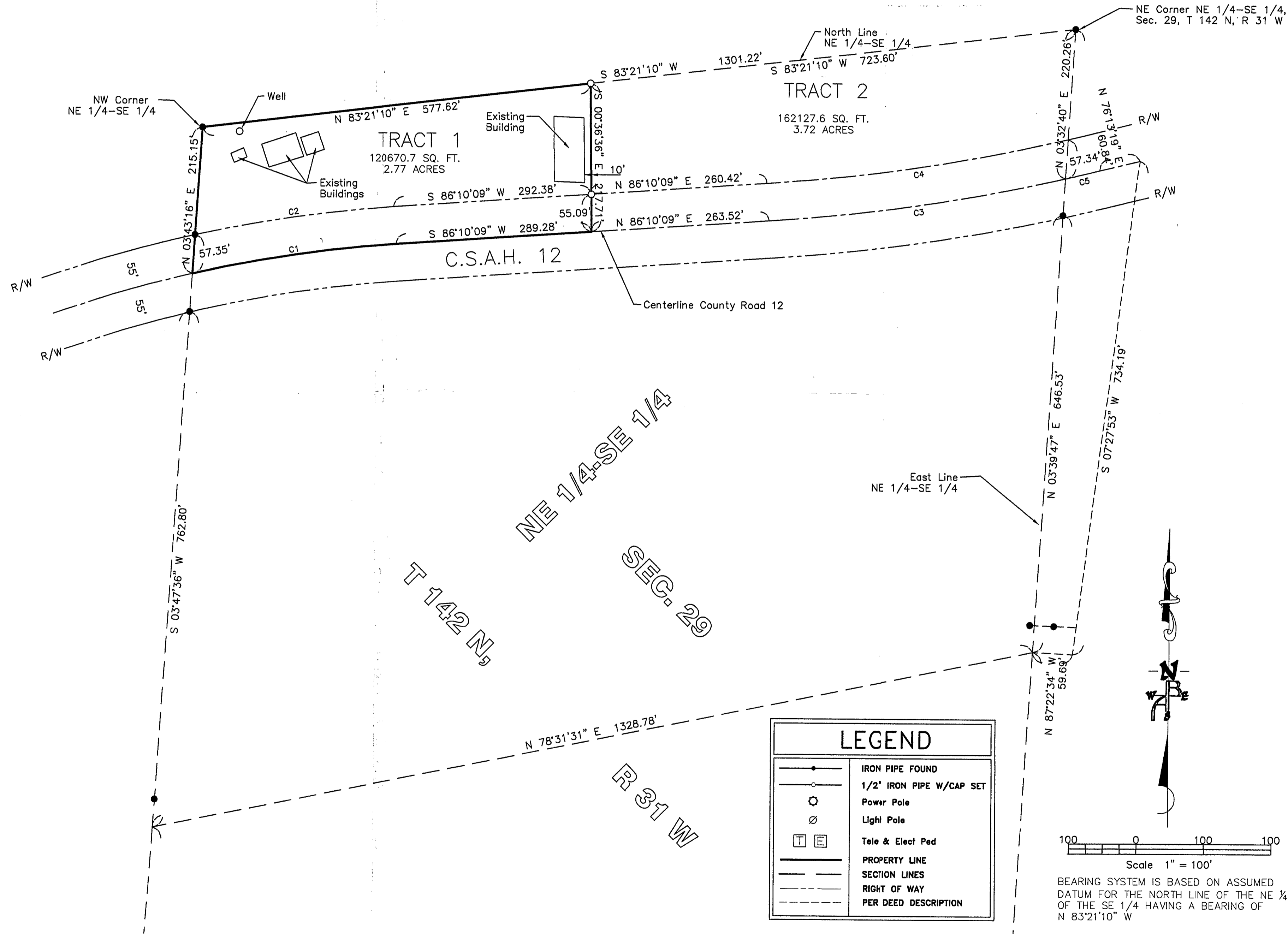


# Certificate of Survey

### TRACT 1

That part of the Northeast Quarter of the Southeast Quarter, lying and being north of County State Aid Highway 12, Section 29, Township 142 North, Range 31 West, Cass County, Minnesota.

### EXCEPT

That part of the Northeast Quarter of the Southeast Quarter, lying and being north of County State Aid Highway 12, Section 29, Township 142 North, Range 31 West, Cass County, Minnesota, lying easterly of the following described line:

Commencing at the northwest corner of said Northeast Quarter of the Southeast Quarter; thence on an assumed bearing of North 83 degrees 21 minutes 10 seconds East along the north line of said Northeast Quarter of the Southeast Quarter a distance of 577.62 feet to the point of beginning of the line to be described; thence South 00 degrees 36 minutes 36 seconds East to the centerline of said County State Aid Highway 12 and there terminating.

Containing 2.77 acres, more or less.

Subject to easement for County Road right-of-way.  
Subject to any and all easements of record.

### TRACT 2

That part of the Northeast Quarter of the Southeast Quarter, lying and being north of County State Aid Highway 12, Section 29, Township 142 North, Range 31 West, Cass County, Minnesota.
