

CERTIFICATE OF SURVEY

All that portion of Lot Seven (7), Section Twenty-five (25), Township One Hundred Forty (140), Range Twenty-nine (29), Cass County, Minnesota, lying and being North and East of the following described line, to-wit: Commencing at the Northwest corner of said Lot 7; thence in a Southeasterly direction to a point on the shore line of Mule Lake equally distant between the intersection with the East boundary line of said Lot 7 and the shore line of Mule Lake and the intersection of the South boundary line of said Lot 7 with the shore line of Mule Lake.

TRACT 1

That part of Government Lot 7, Section 25, Township 140 North, Range 29 West, Cass County, Minnesota, described as follows: Commencing at the Northwest corner of said Government Lot 7 and assuming the north line thereof bears South 76 degrees 37 minutes 34 seconds East; thence South 40 degrees 14 minutes 40 seconds East on a line which passes through a point on the shoreline of Mule Lake which is equally distant between the intersection of the East boundary line of said Lot 7 with the shoreline of Mule Lake and the intersection of the South boundary line of said Lot 7 with the shoreline of Mule Lake 1896.29 feet to the centerline of State Highway No. 84, the point of beginning of the tract to be herein described; thence northeasterly along said centerline to the east line of said Government Lot 7; thence South 0 degrees 04 minutes 27 seconds East along said east line 346 feet, more or less, to the shoreline of Mule Lake; thence southwesterly along said shoreline to the intersection with a line which bears South 40 degrees 14 minutes 40 seconds East from the point of beginning; thence North 40 degrees 14 minutes 40 seconds West 155 feet, more or less, to the point of beginning.

Subject tract is a non-conforming tract and must be attached to an adjoining tract.

That part of Government Lot 7, Section 25, Township 140 North, Range 29 West, Cass County, Minnesota, described as follows: Commencing at the Northwest corner of said Government Lot 7 and assuming the north line thereof bears South 76 degrees 37 minutes 34 seconds East; thence South 40 degrees 14 minutes 40 seconds East on a line which passes through a point on the shoreline of Mule Lake which is equally distant between the intersection of the East boundary line of said Lot 7 with the shoreline of Mule Lake and the intersection of the South boundary line of said Lot 7 with the shoreline of Mule Lake 1502.41 feet to the point of beginning of the tract to be herein described; thence North 89 degrees 55 minutes 33 seconds East 370.60 feet to the east line of said Government Lot 7; thence South 0 degrees 04 minutes 27 seconds East along said east line 59.63 feet to the centerline of State Highway No. 84; thence southwesterly along said centerline to the intersection with a line which bears South 40 degrees 14 minutes 40 seconds East from the point of beginning; thence North 40 degrees 14 minutes 40 seconds West 393.88 feet, more or less, to the point of beginning.

TRACT 3

That part of Government Lot 7, Section 25, Township 140 North, Range 29 West, Cass County, Minnesota, described as follows: Commencing at the Northwest corner of said Government Lot 7 and assuming the north line thereof bears South 76 degrees 37 minutes 34 seconds East; thence South 40 degrees 14 minutes 40 seconds East on a line which passes through a point on the shoreline of Mule Lake which is equally distant between the intersection of the East boundary line of said Lot 7 with the shoreline of Mule Lake and the intersection of the South boundary line of said Lot 7 with the shoreline of Mule Lake 955.80 feet to the point of beginning of the tract to be herein described; thence continuing South 40 degrees 14 minutes 40 seconds East 546.61 feet; thence North 89 degrees 55 minutes 33 seconds East 370.60 feet to the east line of said Government Lot 7; thence North 0 degrees 04 minutes 27 seconds West along said east line 417.68 feet to the intersection with a line bearing North 89 degrees 55 minutes 33 seconds East from the point of beginning; thence South 89 degrees 55 minutes 33 seconds West 723.19 feet to the point of beginning.

That part of Government Lot 7, Section 25, Township 140 North, Range 29 West, Cass County, Minnesota, described as follows: Commencing at the Northwest corner of said Government Lot 7 and assuming the north line thereof bears South 76 degrees 37 minutes 34 seconds East; thence South 40 degrees 14 minutes 40 seconds East on a line which passes through a point on the shoreline of Mule Lake which is equally distant between the intersection of the East boundary line of said Lot 7 with the shoreline of Mule Lake and the intersection of the South boundary line of said Lot 7 with the shoreline of Mule Lake 955.80 feet to the point of beginning of the tract to be herein described; thence North 40 degrees 14 minutes 40 seconds West 327.17 feet; thence North 89 degrees 55 minutes 33 seconds East 934.23 feet to the east line of said Government Lot 7; thence South 0 degrees 04 minutes 27 seconds East along said east line 250.00 feet to the intersection with a line bearing North 89 degrees 55 minutes 33 seconds East from the point of beginning; thence South 89 degrees 55 minutes 33 seconds West 723.19 feet to the point of beginning.
