
CERTIFICATE OF SURVEY



DESCRIPTION:

(PARCEL "A")
That part of Government Lot 4 of Section 5, Township 142, Range 31, Cass County,
Minnesota, which lies westerly of the following described line:

Commencing at the northeast corner of said Government Lot 4; thence on as assumed bearing of North 88 degrees 41 minutes 18 seconds West, along the north line of said government lot, a distance 396.08 feet; thence South 02 degrees 23 minutes 24 seconds West a distance of 500.09 feet to the south line of the North 500.00 feet of said government lot; thence North 88 degrees 41 minutes 18 seconds West, along said south line, a distance of 220.62 feet; thence North 02 degrees 23 minutes 24 seconds East a distance of 500.09 feet to the north line of said government lot, said point also being the point of beginning of the line to be described; thence South 02 degrees 23 minutes 24 West a distance of 1323.37 feet to the south line of said government lot and said line there terminating.

Said parcel contains 20.186 acres of land, more or less, and is subject to existing easements of record.

(PARCEL "B")

That part of Government Lot 4 of Section 5, Township 142, Range 31, Cass County, Minnesota, being described as follows:

Commencing at the northeast corner of said Government Lot 4; thence on as assumed bearing of North 88 degrees 41 minutes 18 seconds West, along the north line of said government lot, a distance 396.08 feet; thence South 02 degrees 23 minutes 24 seconds West a distance of 500.09 feet to the south line of the North 500.00 feet of said government lot; thence North 88 degrees 41 minutes 18 seconds West, along said south line, a distance of 220.62 feet to the point of beginning of the parcel of land to be described; thence South 88 degrees 41 minutes 18 seconds East, along said last course, a distance of 220.62 feet; thence South 02 degrees 23 minutes 24 seconds West a distance of 105.50 feet; thence South 88 degrees 41 minutes 18 seconds East a distance of 395.46 feet to the east line of said government lot; thence South 02 degrees 26 minutes 54 seconds West, along said east government lot line, a distance of 713.62 feet to the southeast corner of said government lot; thence North 89 degrees 04 minutes 41 seconds West, along the south line of said government lot, a distance of 615.45 feet to a line that bears South 02 degrees 23 minutes 24 seconds West from said point of beginning; thence North 02 degrees 23 minutes 24 seconds East a distance of 823.28 feet to the point of beginning

(Proposed Right—of—Way Easement)

A 66.00 foot wide perpetual easement for right—of—way purposes over, under and across the following described property:

Commencing at the northeast corner of said Government Lot 4; thence on as assumed bearing of North 88 degrees 41 minutes 18 seconds West, along the north line of said government lot, a distance 396.08 feet; thence South 02 degrees 23 minutes 24 seconds West a distance of 500.09 feet to the south line of the North 500.00 feet of said government lot; thence North 88 degrees 41 minutes 18 seconds West, along said south line, a distance of 220.62 feet to the point of beginning of the parcel of land to be described; thence South 88 degrees 41 minutes 18 seconds East, along said last course, a distance of 220.62 feet; thence South 02 degrees 23 minutes 24 seconds West a distance of 105.50 feet; thence South 88 degrees 41 minutes 18 seconds East a distance of 395.46 feet to the east line of said government lot; thence South 02 degrees 26 minutes 54 seconds West, along said east government lot line, a distance of 713.62 feet to the southeast corner of said government lot; thence North 89 degrees 04 minutes 41 seconds West, along the south line of said government lot, a distance of 615.45 feet to a line that bears South 02 degrees 23 minutes 24 seconds West from said point of beginning; thence North 02 degrees 23 minutes 24 seconds East a distance of 823.28 feet to the point of beginhing.

The northerly and easterly lines of said easement are described as follows:

Commencing at the northeast corner of said Government Lot 4; thence on as assumed bearing of North 88 degrees 41 minutes 18 seconds West, along the north line of said government lot, a distance 396.08 feet; thence South 02 degrees 23 minutes 24 seconds West a distance of 500.09 feet to the south line of the North 500.00 feet of said government lot; thence North 88 degrees 41 minutes 18 seconds West, along said south line, a distance of 220.62 feet to the point of beginning of the of the line to be described; thence South 88 degrees 41 minutes 18 seconds East, along said last course, a distance of 220.62 feet; thence South 02 degrees 23 minutes 24 seconds West a distance of 105.50 feet; thence South 88 degrees 41 minutes 18 seconds East a distance of 395.46 feet to the east line of said government lot; thence South 02 degrees 26 minutes 54 seconds West, along said east government lot line, a distance of 251.15 feet and said line there terminating.

Said easement is to be extended by its full width to terminate on west with a line that bears South 02 degrees 23 minutes 24 seconds West from the point of beginning and on the south with a line that bears North 89 degrees 04 minutes 41 seconds West from said point of termination.

A 66.00 foot wide perpetual easement for right—of—way purposes over, under and across the North 66.00 feet of the following described property:

That part of Government Lot Three (3), Section Five (5), Township One Hundred Forty—two (142), Range Thirty—one (31), Cass County, Minnesota, described as follows: Commencing at the southwest corner of said Government Lot 3; thence North 2 degrees 26 minutes 54 seconds East, assumed bearing along the West line thereof 283.49 feet to the point of beginning of the tract to be herein described; thence continue North 2 degrees 26 minutes 54 seconds East along said West line 245.00 feet; thence South 89 degrees 04 minutes 41 seconds East 400.09 feet to the southwesterly right of way line of T.H. No. 371; thence South 36 degrees 54 minutes 18 seconds East along said right of way line 356.91 feet to the intersection with a line bearing South 85 degrees 41 minutes 34 seconds East from the point of beginning; thence North 85 degrees 41 minutes 34 seconds West 626.60 feet to the point of beginning.


SURVEYOR NOTES:


2. The field survey was completed on September 18, 2006.
