**DESCRIPTION--(Record)**  
 Government Lot 9, Section Six (6), Township One-Hundred Forty (140), Range Twenty-seven (27), Cass County, Minnesota;  
 AND  
 The Northwest Quarter of the Southeast Quarter (NW 1/4 SE 1/4), Section Six (6), Township One-Hundred Forty (140), Range Twenty-seven (27), Cass County, Minnesota;  
 AND  
 The South two rods of the Southeast Quarter of the Northeast Quarter (SE 1/4 NE 1/4), less the East 330 feet thereof, Section Six (6), Township One-Hundred Forty (140), Range Twenty-seven (27), Cass County, Minnesota.

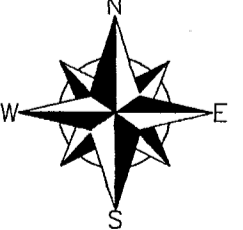
**DESCRIPTION--(PARCEL "A")**  
 That part of the Northwest Quarter of the Southeast Quarter and that part of Government Lot 9 and that part of Government Lot 10 of Section 6, Township 140, Range 27, Cass County, Minnesota, being described as follows:

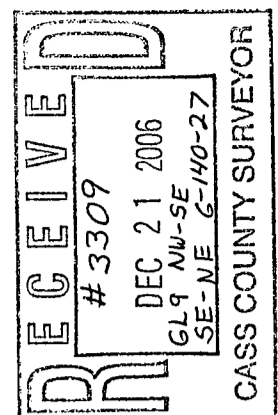
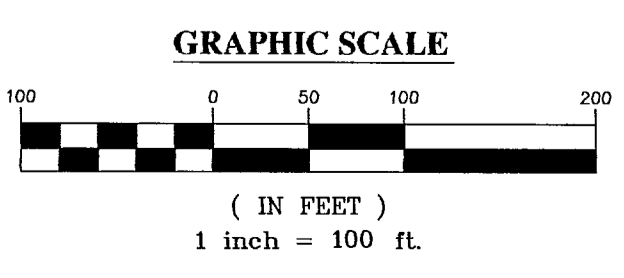
**DESCRIPTION--(Proposed Roadway Easement)**  
 A 66.00 foot wide perpetual easement for roadway purposes over and across that part of the Northwest Quarter of the Southeast Quarter of Section 6, Township 140, Range 27, Cass County, Minnesota. The southeasterly, easterly and southerly lines of said easement are described as follows:  
 Commencing at the northeast corner of Government Lot 10 of said Section 6; thence on an assumed bearing of South 88 degrees 56 minutes 14 seconds West, along the north line of said Government Lot 10, a distance of 1314.58 feet to the northeast corner of said Northwest Quarter of the Southeast Quarter; thence South 00 degrees 14 minutes 51 seconds West, along the east line of said Northwest Quarter of the Southeast Quarter, a distance of 1320.84 feet; thence South 88 degrees 20 minutes 22 seconds West, a distance of 39.21 feet; thence North 00 degrees 57 minutes 22 seconds East, a distance of 228.54 feet to a point hereinafter referred to as Point "A"; thence South 88 degrees 56 minutes 14 seconds West, a distance of 228.54 feet; thence South 88 degrees 56 minutes 14 seconds West, a distance of 112.48 feet; thence South 63 degrees 40 minutes 04 seconds East, a distance of 157.57 feet; thence South 01 degrees 17 minutes 24 seconds West, a distance of 112.48 feet; thence South 63 degrees 40 minutes 04 seconds East, a distance of 157.57 feet; thence South 63 degrees 56 minutes 17 seconds East, a distance of 183 feet, more or less, to the shoreline of Lake Inguadona; thence Northwesterly, along said shoreline, a distance of 197 feet, more or less, to a line that bears North 88 degrees 20 minutes 22 seconds East from said point of beginning; thence South 88 degrees 20 minutes 22 seconds West a distance of 133 feet, more or less, to the point of beginning.  
 The northwesterly and northerly sidelines of said easement are to be prolonged or shortened to terminate on the north line of said Northwest Quarter of the Southeast Quarter and on a line that bears North 01 degrees 16 minutes 25 seconds East from said point of termination.

 Together with a perpetual easement for roadway purposes over and across that part of Government Lot 10 of Section 6, Township 140, Range 27, Cass County, Minnesota. Said easement is described as follows:  
 Commencing the northeast corner of said Government Lot 10 of said Section 6; thence on an assumed bearing of South 88 degrees 56 minutes 14 seconds West, along the north line of said government lot, a distance of 1314.58 feet to the northwest corner of said government lot, said point also being the point of beginning of the easement to be described; thence South 00 degrees 14 minutes 51 seconds West, along the west line of said government lot, a distance of 45.42 feet; thence North 57 degrees 33 minutes 29 seconds East, a distance of 87.20 feet to the north line of said government lot; thence South 88 degrees 56 minutes 14 seconds West, along said north government lot line, a distance of 87.20 feet to the point of beginning.

 Together with a perpetual easement for roadway purposes over and across the South two rods of the Southeast Quarter of the Northeast Quarter of said section 6.



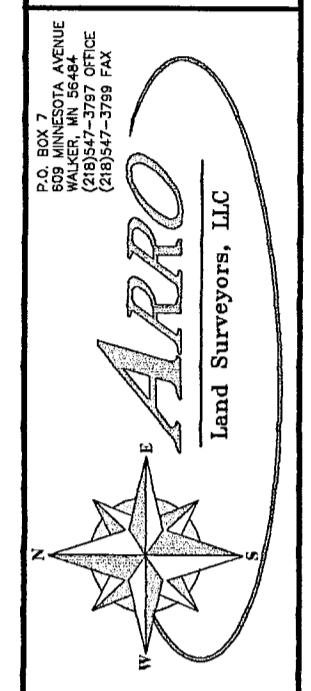
