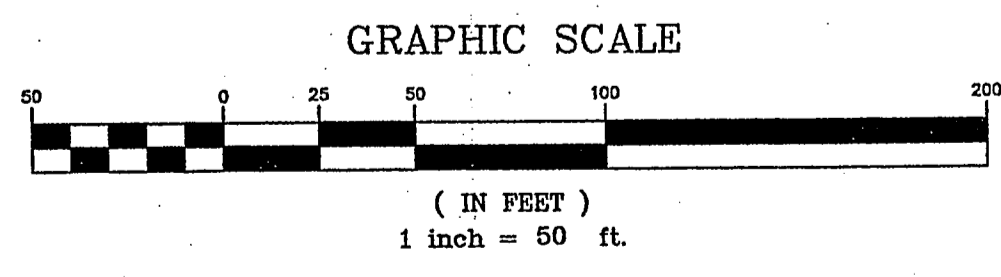
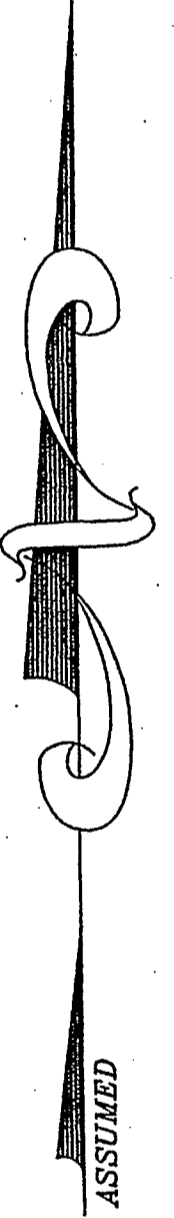
**PROPOSED DESCRIPTION PARCEL B:**
