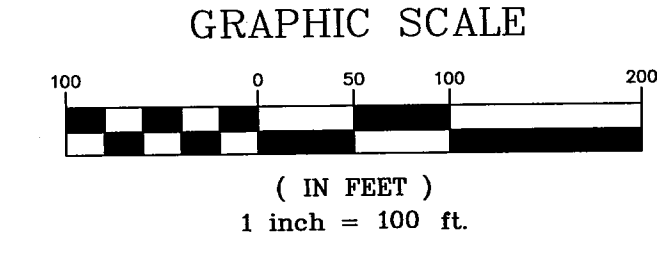
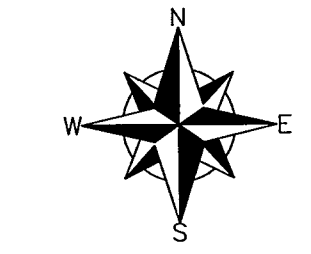
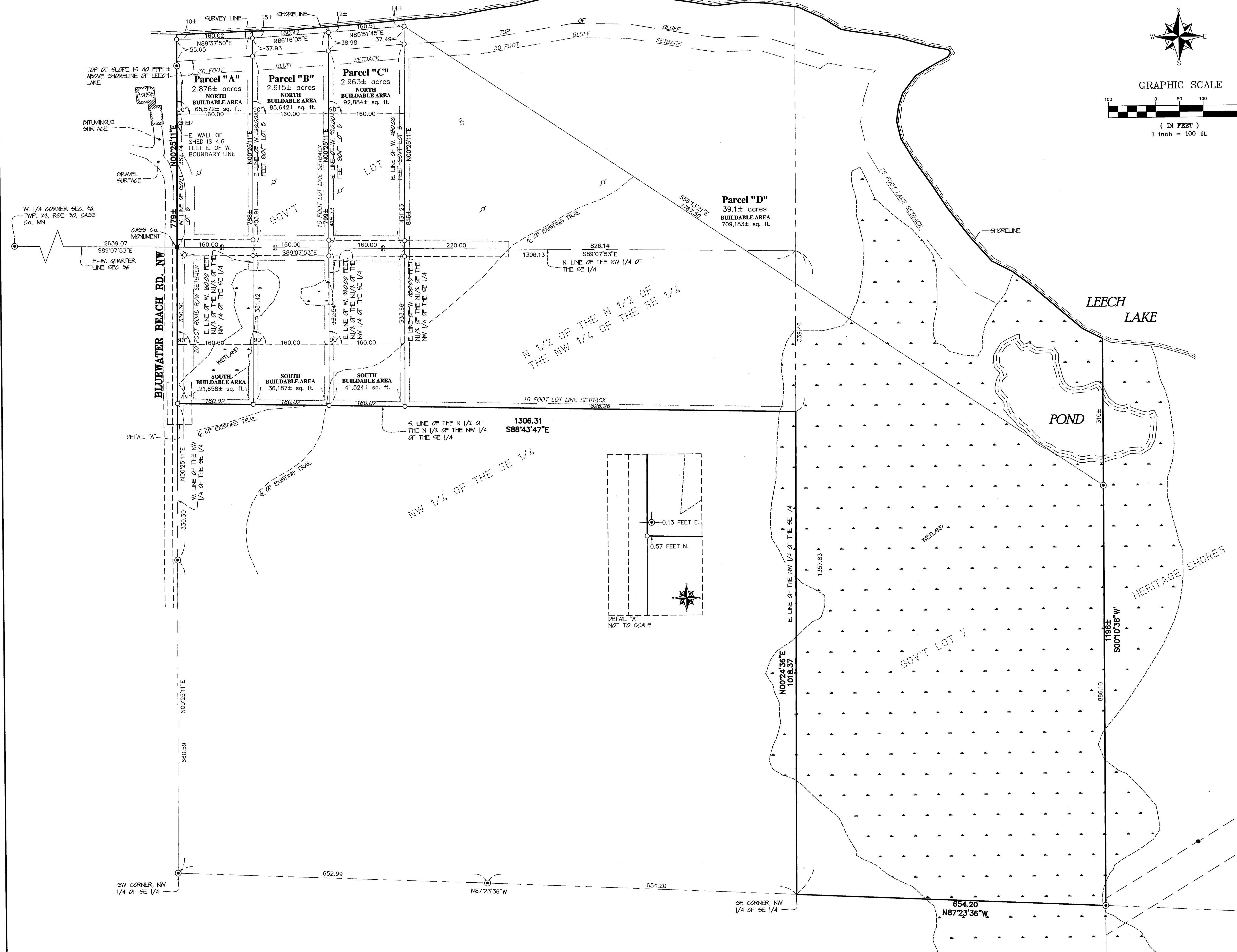

The West 160.00 feet of Government Lot 8 and the West 160.00 feet of the North Half of the North Half of the Northwest Quarter of the Southeast Quarter all in Section 36, Township 142, Range 30, Cass County, Minnesota.

Said parcel contains 2.9 acres of land, more or less, and is subject to existing easements of record.

PROPOSED PARCEL "B"

The East 160.00 feet of the West 320.00 feet of Government Lot 8 and the East 160.00 feet of the West 320.00 feet of the North Half of the North Half of the Northwest Quarter of the Southeast Quarter all in Section 36, Township 142, Range 30, Cass County, Minnesota.

Said parcel contains 2.9 acres of land, more or less, and is subject to existing easements of record.

PROPOSED PARCEL "C"

The East 160.00 feet of the West 480.00 feet of Government Lot 8 and the East 160.00 feet of the West 480.00 feet of the North Half of the North Half of the Northwest Quarter of the Southeast Quarter all in Section 36, Township 142, Range 30, Cass County, Minnesota.

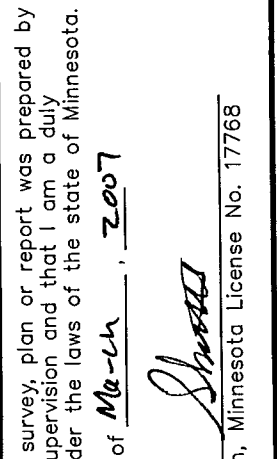
Said easement is described as follows:

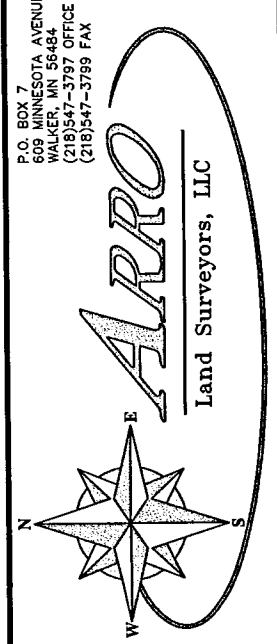

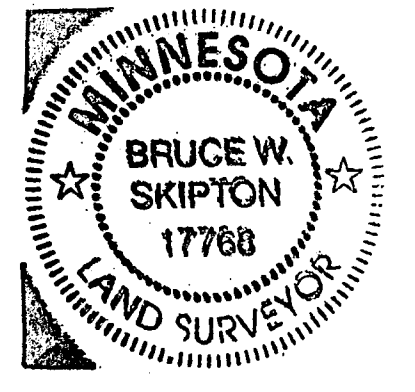
