# **CERTIFICATE OF SURVEY**

## TRACT A

That part of Lot 5 of OAKHURST, according to the recorded plat thereof on file in the Cass County Recorder's Office, described as follows: Commencing at the most southerly corner of Lot 6 of said OAKHURST; thence North 19 degrees 21 minutes 38 seconds East, 782.03 feet, assumed bearing, along the easterly line of said Lot 6 to the line common to Lots 5 and 6 of said OAKHURST, to the point of beginning of the tract to be described; thence continuing North 19 degrees 21 minutes 38 seconds East 104.24 feet along the easterly line of said Lot 5 to its intersection with the line distant 100.00 feet northeasterly as measured at right angles to and parallel with said line common to Lots 5 and 6 of said OAKHURST; thence North 54 degrees 14 minutes 09 seconds West 225 feet, more or less, along said parallel line to the shore of Gull Lake; thence southwesterly along said shore to its intersection with said line common to Lots 5 and 6; thence South 54 degrees 14 minutes 09 seconds East 261 feet, more or less, along said line common to Lots 5 and 6 to the point of beginning. 


APPROXIMATE EDGE
