BEGINNING at the southwest corner of said Lot 1; thence North 80 degrees 16 minutes 28 seconds East, assumed bearing, along the southerly line of said Lot 1, a distance of 97.21 feet, to an angle point of said Lot 1; thence North 57 degrees 00 minutes 28 seconds East, along the southeasterly line of said Block One, a distance of 53.18 feet; thence North 21 degrees 33 minutes 07 seconds West 170.84 feet; thence North 68 degrees 26 minutes 53 seconds East 17.56 feet; thence North 21 degrees 33 minutes 07 seconds West 108 feet, more or less, to the shoreline of Ten Mile Lake; thence southwesterly along said shoreline to the intersection with the westerly line of said Lot 1; thence South 09 degrees 43 minutes 32 seconds East, along said westerly line, 200 feet, more or less, to the point of beginning.

A 33.00 foot wide easement for ingress, egress, and utility purposes over, under, and across those parts of Lots 1, 2, 3, 4, and 5, Block One, BALL'S FIRST ADDITION TO GITCHE GUMEE BEACH, according to the recorded plat thereof, Cass County, Minnesota, the centerline of said 33.00 foot wide easement is described as follows:

COMMENCING at the southwest corner of said Lot 1; thence North 80 degrees 16 minutes 28 seconds East, assumed bearing, along the south line of said Lot 1, a distance of 97.21 feet to an angle point of said Lot 1 and the point of beginning of the centerline to be herein described; thence North 57 degrees 00 minutes 28 seconds East, along the southeasterly line of said Block One, a distance of 241.83 feet; thence northerly 85.12 feet, along a non-tangential curve, concave to the west, having a radius of 125.00 feet, a central angle of 39 degrees 00 minutes 59 seconds, a chord bearing of North 17 degrees 13 minutes 53 seconds East, and a chord distance of 83.49 feet; thence North 02 degrees 16 minutes 36 seconds West, tangent to said curve, 73.46 feet; thence North 08 degrees 18 minutes 37 seconds West 60.06 feet; thence North 01 degree 45 minutes 56 seconds East 10.83 feet to the northeasterly line of said Lot 5, Block One, and said described centerline there terminating.

The sidelines of said 33.00 foot wide easement shall be prolonged or shortened to terminate on the northeasterly line of said Lot 5, Block One and on lines bearing South 80 degrees 16 minutes 28 seconds West and North 57 degrees 00 minutes 28 seconds East from the point of beginning of the above described centerline.
