
CERTIFICATE OF SURVEY


PROPOSED LEGAL DESCRIPTIONS:

The Northerly 845.83 feet of the Northwest Quarter of the Southwest Quarter, (NW1/4-SW1/4), Section Sixteen (16), Township One Hundred Thirty-four (134), Range Twenty-nine (29) West, Cass County, Minnesota, Except the following: The Westerly 660.00 feet thereof and Except the Northerly 478.00 feet thereof, and Except: The Northerly 705.83 of the Easterly 432.00 feet thereof. Together with an easement for ingress and egress across the Westerly 33.00 feet of the Easterly 465.00 feet of the Northerly 478.00 feet of said NW1/4-SW1/4 and Subject to a 33.00 foot wide easement for ingress and egress across said NW1/4-SW1/4, the west line of said easement being described as follows: Commencing at the intersection of the west line of said Easterly 432.00 feet of the NW1/4-SW1/4 with the south line of said Northerly 478.00 feet of the NW1/4-SW1/4; thence South 89 degrees 32 minutes 05 seconds West, assumed bearing, 42.53 feet along said south line of the Northerly 478.00 feet of the NW1/4-SW1/4 to the point of beginning of the line to be described; thence South 03 degrees 29 minutes 14 seconds West 114.81 feet; thence South 01 degree 14 minutes 03 seconds West 173.49 feet; thence South 30 degrees 23 minutes 30 seconds East 92.17 feet to the south line of said Northerly 845.83 feet of the NW1/4-SW1/4 and said line there terminating. Subject to other easements, reservations or restrictions of record, if any.

Together with an easement for ingress and egress across the Westerly 33.00 feet of the Easterly 465.00 feet of the Northerly 478.00 feet of said NW1/4-SW1/4 and Together with a 33.00 foot wide easement for ingress and egress across said NW1/4-SW1/4, the west line of said easement being described as follows: Commencing at the intersection of the west line of the Easterly 432.00 feet of said NW1/4-SW1/4 with the south line of said Northerly 478.00 feet of the NW1/4-SW1/4; thence South 89 degrees 32 minutes 05 seconds West, assumed bearing, 42.53 feet along said south line of the Northerly 478.00 feet of the NW1/4-SW1/4 to the point of beginning of the line to be described; thence South 03 degrees 29 minutes 14 seconds West 114.81 feet; thence South 01 degree 14 minutes 03 seconds West 173.49 feet; thence South 30 degrees 23 minutes 30 seconds East 92.17 feet to the south line of said Northerly 845.83 feet of the NW1/4-SW1/4 and said line there terminating.
