SURVEY NOTES:

- The south boundary of Tract A was written to approximate the westerly extension of the south edge of the deck shown on
 the west side of the house. This line was determined by the client, in negotiations with the seller of Tract A based on their
 observations in the field. The location of the river in relation to this line was not surveyed and is unknown to Landecker
 and Associates.
- The purpose of this survey was only to address concerns with respect to access and the encroachment of the pole building shown near the west boundary line of the existing tract. Other important features may exist south of the pole building and near the rest of the boundary lines which have not been surveyed or shown.
- All lines marked with lath and flagging are only an approximation of the true boundary lines and are not to be used as an
 exact boundary location. Flagged lines should not be used for the establishment of improvements. To mark true boundary
 lines, additional monumentation would be required.
- 4. Some utilities have been shown from observed field inspection when visible at the time of survey. Other utilities exist that have not been surveyed or shown. Contact "Gopher One-Call" 1-800-252-1166 for exact locations prior to construction.





SECTION NOTES:

- 1. This survey is based on physical and record evidence from the Bureau of Land Management Survey Dated April 3, 1980.
- 2. The section was subdivided as a fractional section. The north-south 1/16 line in the Southwest Quarter was computed as a mean bearing between the measured west section line and a mean bearing for the north-south Quarter line that was based on the measured east and west section lines. The north-south quarter line bearing as shown, however, is based on recovered boundary control from a previous survey prepared by Landecker and Associates in the Southeast Quarter.
