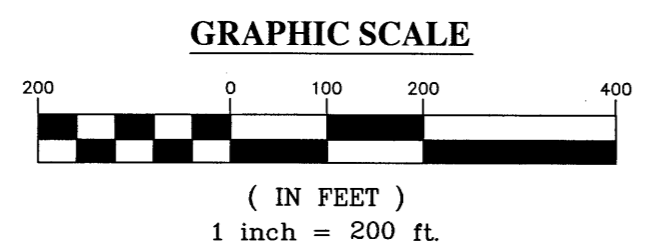
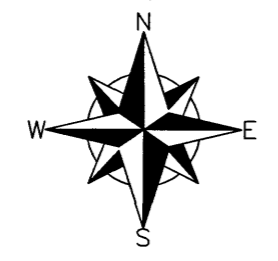
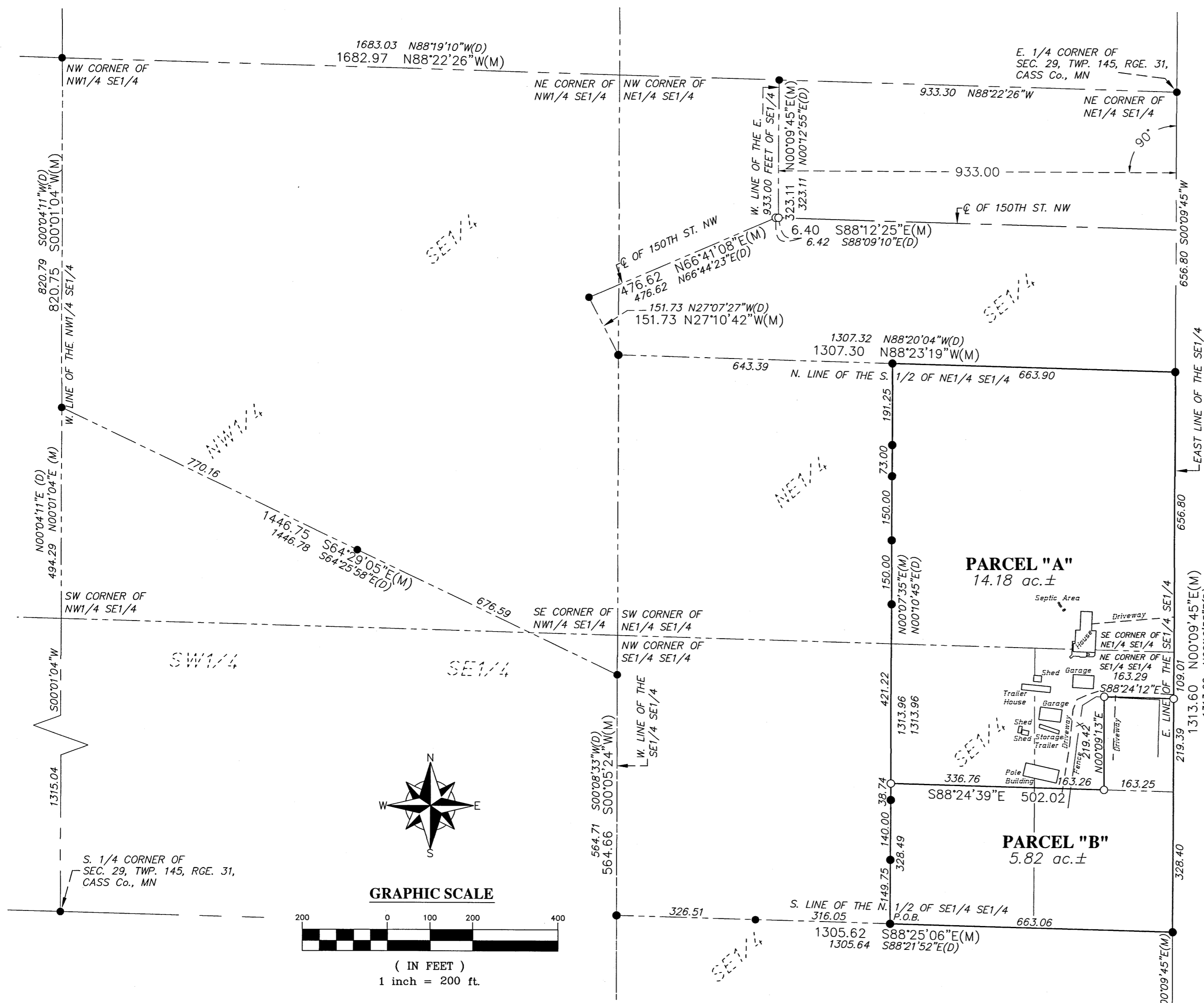


CERTIFICATE OF SURVEY
