AMENDMENT TO CONTRACT FOR DEEL OUNTY RECORDER

WHEREAS, Patricia A. Mitchell, single (hereinafter Mitchell), Jean Dow, single, Andrew R. Larson, trustee of the Larson Family Revocable Trust dated 10/04/02 (hereinafter Larson) and Donald E. Spinar, trustee of the Spinar Family Trust dated 05/13/02, Sellers, agreed to sell to Gary W. Paulson and Susan L. Paulson, husband and wife, Buyers, (hereinafter Paulson) by contract for deed dated 12 April 2005 and recorded on 5 July 2005 in the Cass County Recorder's office as document no. A000500649, certain real property described as:

That part of Government Lot 2, Section 34, Township 141 North, Range 31, West, Cass County, Minnesota described as follows: Commencing at the Northwest corner of said Government Lot 2; thence on an assumed bearing of South 1 degree 17 minutes East 600 feet along the West line of Government Lot 2; thence South 83 degrees 18 minutes East 1,235.65 feet; thence South 40 degrees 03 minutes West 110 feet; thence South 26 degrees 50 minutes 44 seconds West 77.36 feet to the point of beginning of the tract to be described: thence South 1 degree 36 minutes 07 seconds East 52.62 feet; thence South 23 degrees 35 minutes East 60 feet; thence South 87 degrees 28 minutes 47 seconds East 315 feet, more or less, to the water's edge of Ten Mile Lake; thence Northerly 125 feet, more or less, along said water's edge to the intersection with a line which bears North 89 degrees 17 minutes 24 seconds East from the point of beginning; thence South 89 degrees 17 minutes 24 seconds West 348 feet, more or less, to the point of beginning, subject to and together with an easement for the existing township road and subject to other easements, restrictions or reservations, if any and further subject to and together with a non exclusive easement 12 feet in width on over and across the existing drive extending from the above described property in an easterly and northerly direction to its intersection with the county road. 


PROPOSED EASEMENT DESCRIPTION:

20.00 FOOT WIDE EASEMENT

A 20.00 foot wide easement for ingress, egress, and utility purposes over, under, and across that part of Government Lot 2, Section 34, Township 141 North, Range 31 West, Cass County, Minnesota, the southerly line of said 20.00 foot wide easement is described as follows: COMMENCING at the northwest corner of said Government Lot 2; thence South 01 degrees 17 minutes 00 seconds East, assigned bearing, along the west line thereof 600.00 feet; thence South 83 degrees 18 minutes 00 seconds East 1235.65 feet; thence South 40 degrees 03 minutes 00 seconds West 110.00 feet; thence South 26 degrees 50 minutes 44 seconds West 77.36 feet to the point of beginning of the southerly line to be herein described; thence North 89 degrees 17 minutes 24 seconds East 124.75 feet and said described southerly line there terminating.

The northerly line of the above described 20.00 foot wide easement shall be prolonged or shortened to terminate on the centerline of Black Spruce Trail.
