
CERTIFICATE OF SURVEY

A PARCEL OF LAND IN GOVERNMENT LOT 1, SECTION 21, TOWNSHIP 143 NORTH, RANGE 31 WEST AND IN THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 16, TOWNSHIP 143 NORTH, RANGE 31 WEST, CASS COUNTY, MINNESOTA, DESCRIBED AS FOLLOWS; COMMENCING AT THE SOUTHEAST CORNER OF THE SOUTHWEST QUARTER OF SAID SECTION 16, THENCE NORTH 90°00'00'WEST 65.16 FEET ALONG THE SOUTH LINE OF SAID SECTION 16 TO THE POINT OF BEGINNING; THENCE NORTH 16°51'59'WEST 380.71 FEET TO THE SOUTHERLY LINE OF THE TRACT WHICH WAS FORMERLY THE RIGHT-OF-WAY OF THE GREAT NORTHERN RAILWAY; THENCE SOUTHWESTERLY ALONG SAID SOUTHERLY LINE OF THE GREAT NORTHERN RAILWAY 280.74 FEET; THENCE SOUTH 25°52'27' EAST A DISTANCE OF 516 FEET MORE OR LESS TO THE SHORE OF LESS TO A POINT WHICH IS SOUTH 16°51'59' EAST OF THE POINT OF BEGINNING, THENCE NORTH 16°51'59'W A DISTANCE OF 138.3 FEET MORE OR LESS.
