

CERTIFICATE OF SURVEY

Commencing at the Northeast corner of said South 409.63 feet of said Northwest Quarter of the Southwest Quarter, thence North 02 degrees 57 minutes 11 seconds West, assumed bearing, along the East line of said Northwest South line of the North 575.00 feet of the North 575.00 feet of said Northwest Quarter of the Southwest Quarter, thence South 88 degrees 16 minutes 38 seconds West along said South line 250.06 feet, more or less, to the West line of the East 250.00 feet of said Quarter Quarter, thence North 02 degrees 57 minutes 11 seconds West along said West line 150.89 feet, more or less, to the South line of the North 424.15 feet of said Quarter Quarter, thence South 88 degrees 16 minutes 38 seconds West along said last described South line 413.53 feet, more or less, to the East line of the West 660.00 feet of said Quarter Quarter, thence North 02 degrees 50 minutes 52 seconds West along said last described East line 61.16 feet, more or less, to the South line of the North 363.00 feet of said Quarter Quarter, thence South 88 degrees 16 minutes 38 seconds West along said last described South line 57 feet, more or less, to the Easterly shoreline of Stoney Brook and said described line there terminating.

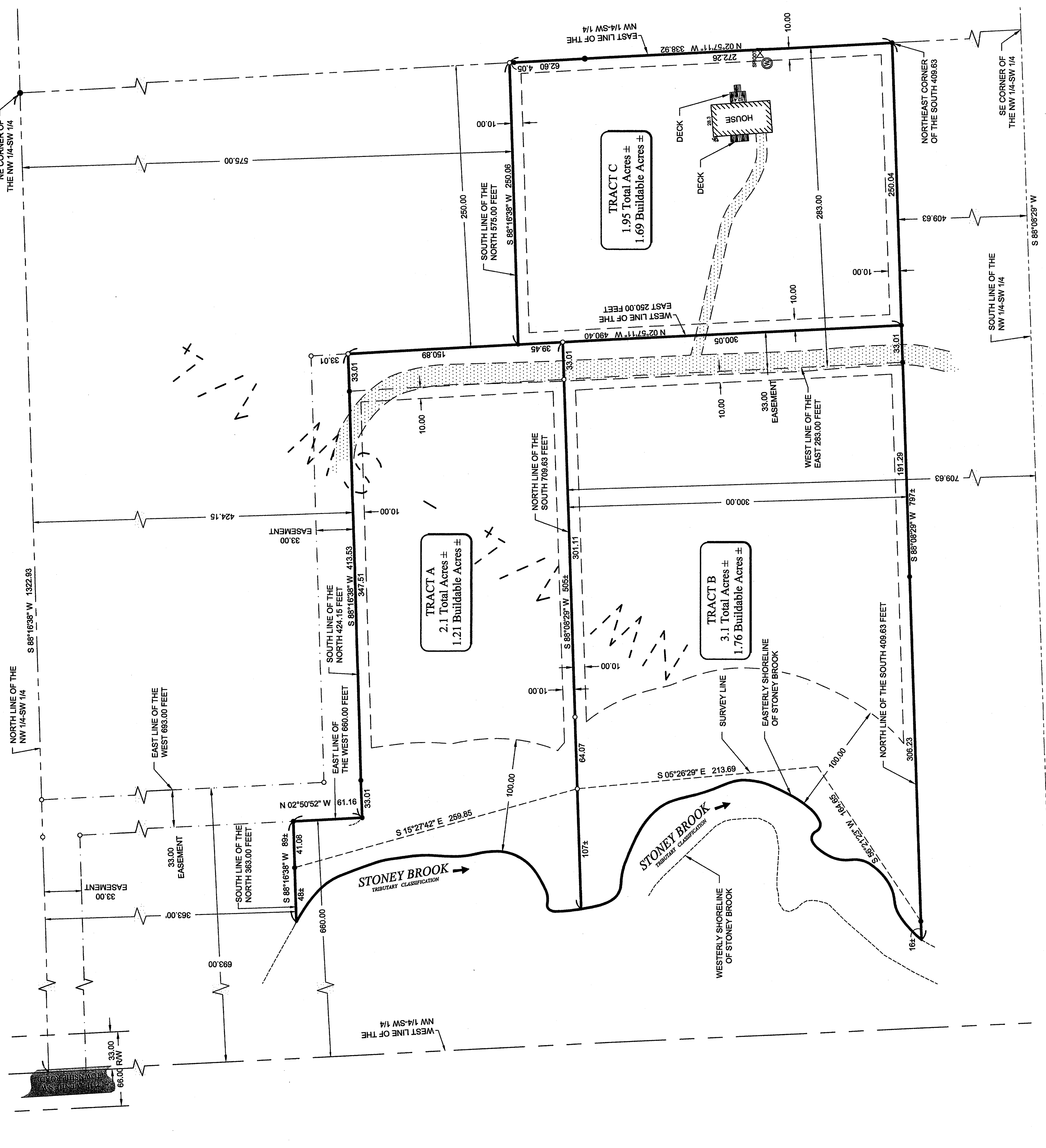
