EASEMENT LEGAL DESCRIPTION

A 120.00 foot easement for utility purposes over, under and across the Northwest Quarter of the Northeast Quarter, Section 22, Township 139 North, Range 27 West of the Fifth Principal Meridian, Cass County, Minnesota, with a centerline described as follows:

Commencing at the North Quarter corner of said Section 22; thence South 0 degrees 49 minutes 27 seconds West along the west line of said Northwest Quarter of the Northeast Quarter, a distance of 325.98 feet to the point of beginning of the centerline to be described; thence South 89 degrees 20 minutes 27 seconds East, a distance of 877.78 feet; thence South 89 degrees 32 minutes 46 seconds East, a distance of 418.85 feet to the east line of said Northwest Quarter of the Northeast Quarter and said easement centerline there terminates.

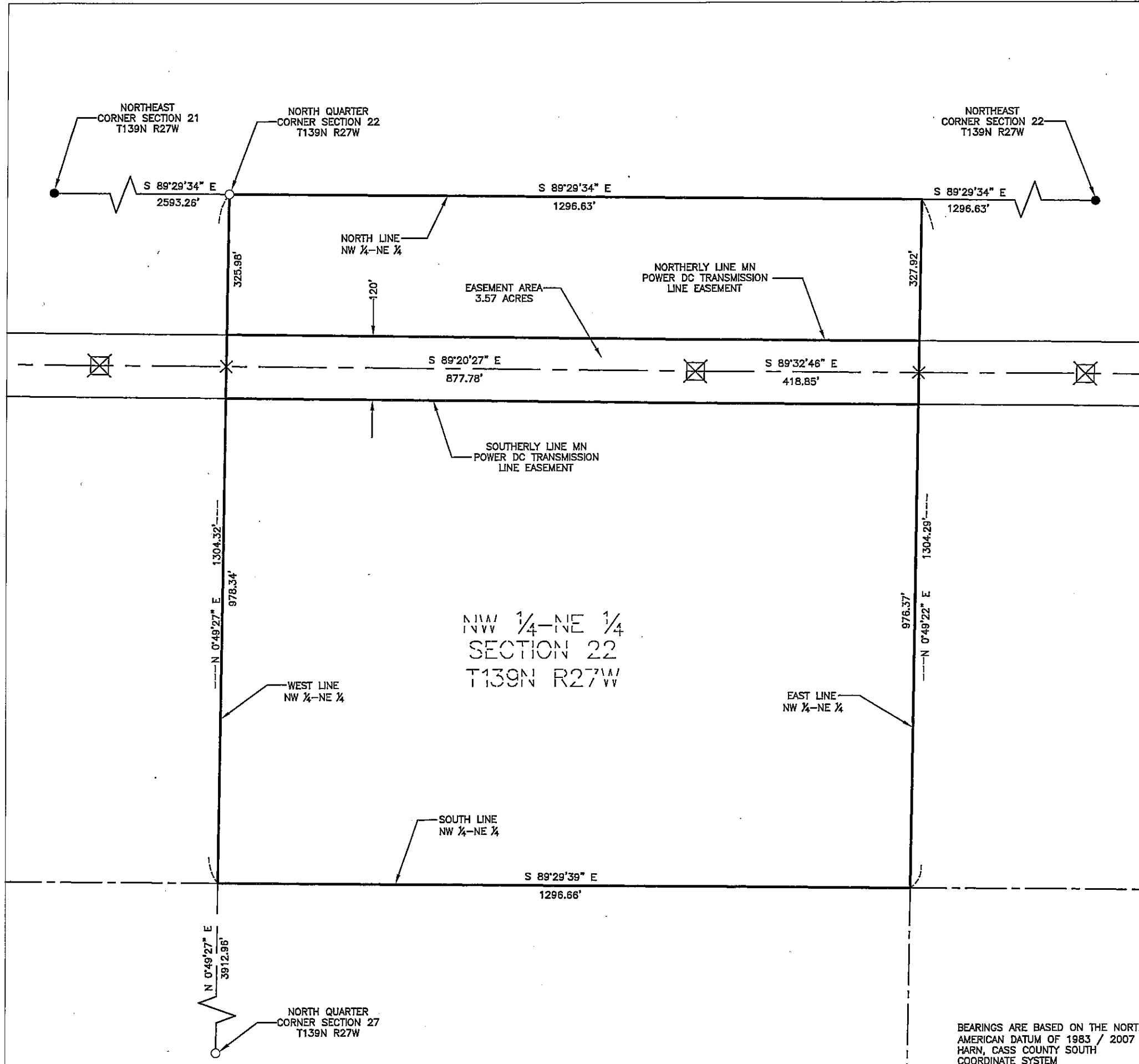
The sidelines of said easement are to be prolonged or shortened to terminate on the west line, and on the east line of said Northwest Quarter of the Northeast Quarter.

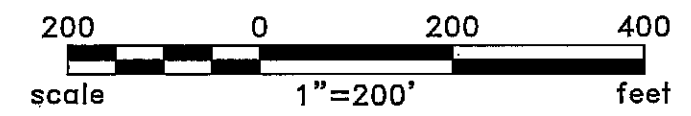

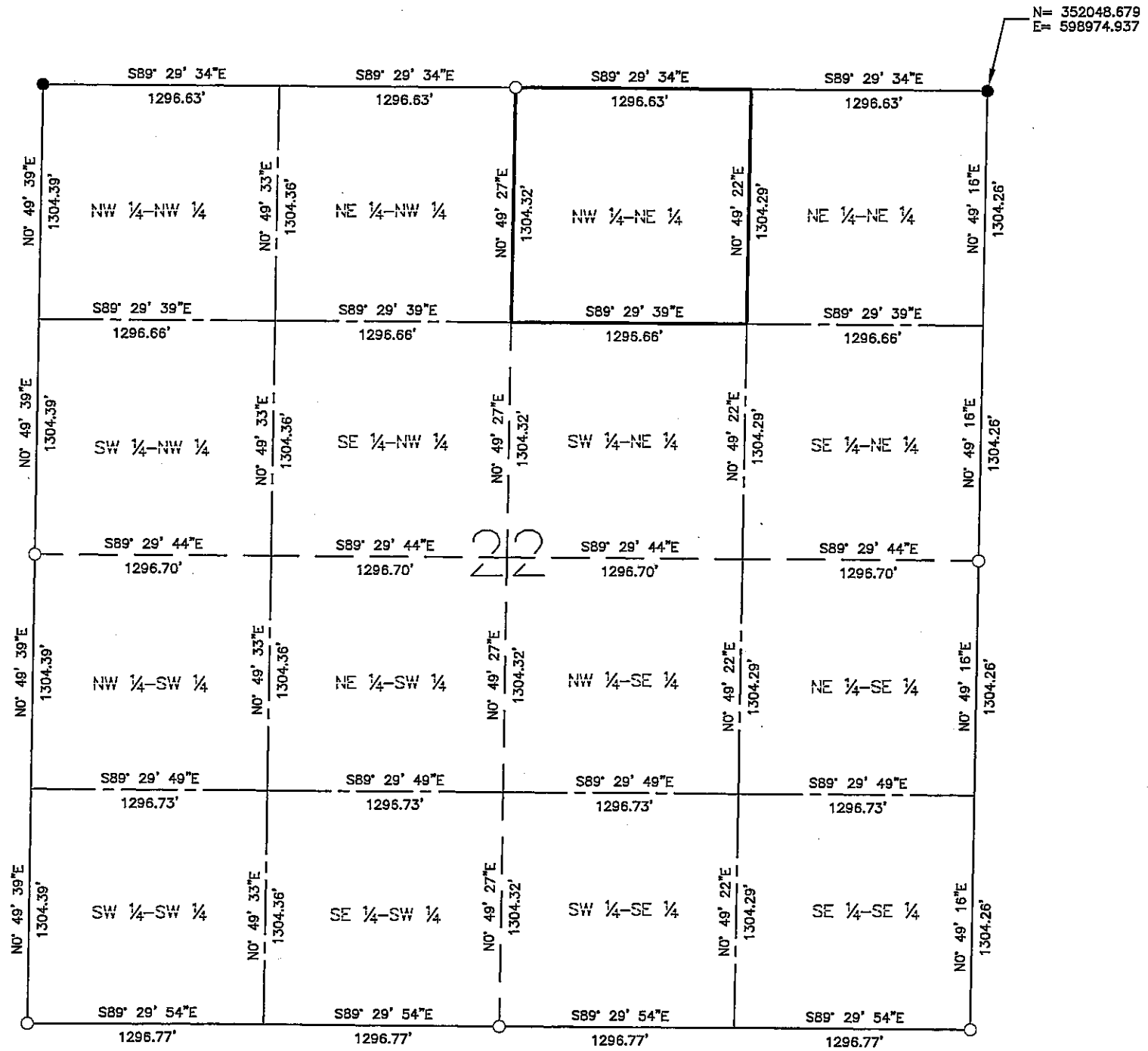

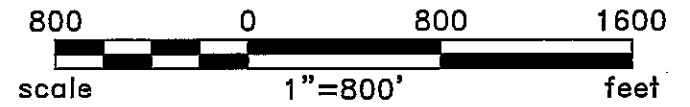
