ALSO EXCEPT

Tract B1: That part of Lot B-18 AUDITOR'S PLAT OF PINE BEACH, according to the recorded plat on file in the Cass County Recorder's Office described as follows: Commencing at the concrete monument which is the Northwest corner of said Lot B-18; thence South 04 degrees 32 minutes 39 seconds East, assumed bearing, 200.00 feet along the West line of said Lot B-18; thence South 26 degrees 11 minutes 21 seconds East 185.53 feet along said West line of Lot B-18 to a point hereinafter designated Point "A"; thence South 26 degrees 11 minutes 21 seconds East 295.84 feet along said West line of Lot B-18 to an iron monument; the point of beginning of the tract to be described; thence reversing North 26 degrees 11 minutes 21 seconds West 138.38 feet along said West line of Lot B-18 to an iron monument; thence North 73 degrees 18 minutes 23 seconds East 177.40 feet to an iron monument; thence North 03 degrees 35 minutes 31 seconds West 48.64 feet to an iron monument; thence North 40 degrees 59 minutes 34 seconds East 40.60 feet to an iron monument; thence North 15 degrees 55 minutes 18 seconds East 55.33 feet to an iron monument; thence North 59 degrees 37 minutes 05 seconds East 122 feet, more or less, to the shore of Gull Lake; thence southerly along said shore to its intersection with the line that bears North 67 degrees 39 minutes 40 seconds East from the point of beginning; thence South 67 degrees 39 minutes 40 seconds West 421 feet, more or less, to the point of beginning. Tract B2: That part of Lot B-18 Auditor's Plat of Pine Beach, according to the plat on file in the Cass County Recorder's Office described as follows: Commencing at the concrete monument which is the Northwest corner of said Lot B-18; thence South 04 degrees 32 minutes 39 seconds East, assumed bearing, 200.00 feet along the West line of said Lot B-18; thence South 26 degrees 11 minutes 21 seconds East 481.37 feet along said West line of Lot B-18 to an iron monument, the point of beginning of the tract to be described; thence North 67 degrees 39 minutes 40 seconds East 421 feet, more or less, to the shore of Gull Lake; thence southerly along said shore to its intersection with the South line of said Lot B-18; thence South 73 degrees 54 minutes 36 seconds West 444 feet, more or less, along said South line of Lot B-18 to the iron monument at the Southwest corner of said Lot B-18; thence North 26 degrees 11 minutes 21 seconds West 150.00 feet along said west line of Lot B-18 to the point of beginning.

TRACT A
That part of Lot B 18, AUDITOR'S PLAT OF PINE BEACH, according to the recorded plat thereof, Cass County, Minnesota, described as follows: Commencing at the Northwest corner of said Lot B 18; thence South 04 degrees 32 minutes 39 seconds East, assumed bearing, along the west line of said Lot B 18 for a distance of 199.94 feet; thence South 26 degrees 14 minutes 12 seconds East along said west line 44.20 feet to the point of beginning of the tract to be herein described; thence continuing South 26 degrees 14 minutes 12 seconds East along said west line 15.10 feet to the monumented line described in Document A000575001 on file in the office of the County Recorder said county; thence North 70 degrees 23 minutes 28 seconds East along said line 388 feet to the shoreline of Gull Lake; thence northwesterly along said shoreline to the intersection with a line bearing North 70 degrees 23 minutes 28 seconds East from the point of beginning; thence South 70 degrees 23 minutes 28 seconds West 388 feet, more or less, to the point of beginning.

That part of Lot B 18, AUDITOR'S PLAT OF PINE BEACH, according to the recorded plat thereof, Cass County, Minnesota, lying northerly of the following described line; Commencing at the Northwest corner of said Lot B 18; thence South 04 degrees 32 minutes 39 seconds East, assumed bearing, along the west line of said Lot B 18 for a distance of 199.94 feet; thence South 26 degrees 14 minutes 12 seconds East along said west line 44.20 feet to the point of beginning of the line to be herein described; thence North 70 degrees 23 minutes 28 seconds East 388 feet, more or less, to the shoreline of Gull lake and said described line there terminating.

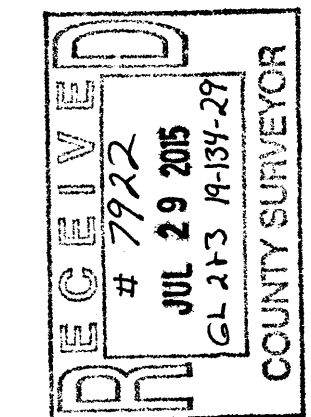
