ORIGINAL DESCRIPTIONS

TRACT 5

Those parts of the Southeast Quarter of the Southwest Quarter and Government Lot 5, all in Section 27, Township 142 North, Range 31 West, Cass County, Minnesota, described as follows: Commencing at the Southeast corner of said Government Lot 5; thence North 6 degrees 52 minutes 16 seconds East along the east line of said Government Lot 5 a distance of 156.55 feet; thence North 77 degrees 54 minutes 18 seconds West 320.95 feet to the point of beginning of the tract to be herein described; thence North 76 degrees 33 minutes 03 seconds West 558.49 feet, thence South 11 degrees 43 minutes 45 seconds East 499.87 feet to the intersection with a line bearing South 50 degrees 50 minutes 46 seconds West from the point of beginning; thence North 50 degrees 50 minutes 46 seconds East 569.43 feet to the point of beginning.

ROAD EASEMENT

An easement for ingress, egress and utilities 66.00 feet in width over, under and across that part of the Southeast Quarter of the Southwest Quarter, Section 27, Township 142 North, Range 31 West, Cass County, Minnesota, the centerline of which is described as follows: Commencing at the Southwest corner of said Southeast Quarter of the Southwest Quarter; thence North 6 degrees 51 minutes 59 seconds East, assumed bearing along the west line of said Southeast Quarter of the Southwest Quarter 681.58 feet; thence South 85 degrees 15 minutes 49 seconds East 359.68 feet; thence South 17 degrees 04 minutes 14 seconds West 335.52 feet; thence on a bearing of West 44.72 feet to a point in the centerline of the township road as described; thence South 70 degrees 31 minutes 40 seconds East along said described centerline 397.55 feet to the point of beginning of the centerline to be herein described; thence North 4 degrees 19 minutes 35 seconds East 149.50 feet; thence North 35 degrees 18 minutes 40 seconds East 262.24 feet; thence North 18 degrees 25 minutes 38 seconds West 420.00 feet and said centerline there terminating. And an easement for ingress, egress and utilities over, under and across part of said Southeast Quarter of the Southwest Quarter which lies within the circumference of a circle having a radius of 66.00 feet. The center of said circle is the above said point of termination.

Those parts of the Southeast Quarter of the Southwest Quarter and Government Lot 5, all in Section 27, Township 142 North, Range 31 West, Cass County; Minnesota, described as follows: Commencing at the southeast comer of said Government Lot 5; thence North 6 degrees 52 minutes 16 seconds East, assigned bearing, along the east line of said Government Lot 5, a distance of 156.55 feet; thence North 77 degrees 54 minutes 18 seconds West 320.95 feet to a point hereinafter referred to as Point "A"; thence North 76 degrees 33 minutes 03 seconds West 346.20 feet; thence South 23 degrees 33 minutes 24 seconds East 191.10 feet to the point of beginning of the tract to be herein described; thence North 23 degrees 33 minutes 24 seconds West 191.10 feet; thence North 76 degrees 33 minutes 03 seconds West 212.29 feet; thence South 11 degrees 43 minutes 45 seconds East 499.87 feet to the intersection with a line bearing South 50 degrees 50 minutes 46 seconds West from the said Point "A"; thence North 50 degrees 50 minutes 46 seconds East, toward said Point "A", 438.31 feet to the intersection with a line bearing North 85 degrees 43 minutes 20 seconds East from the point of beginning; thence South 85 degrees 43 minutes 20 seconds West 159.10 feet to the point of beginning.

That part of Government Lot 5, Section 27, Township 142 North, Range 31 West, Cass County, Minnesota, described as follows: Commencing at the southeast corner of said Government Lot 5; thence North 6 degrees 52 minutes 16 seconds East, assigned bearing, along the east line of said Government Lot 5, a distance of 156.55 feet; thence North 77 degrees 54 minutes 18 seconds West 320.95 feet to the point of beginning of the tract to be herein described; thence North 76 degrees 33 minutes 03 seconds West 346.20 feet; thence South 23 degrees 33 minutes 24 seconds East 191.10 feet; thence North 85 degrees 43 minutes 20 seconds East 159.10 feet to the intersection with a line bearing South 50 degrees 50 minutes 46 seconds West from the point of beginning; thence North 50 degrees 50 minutes 46 seconds East 131.12 feet to the point of beginning.

TRACT 5B is a nonconforming parcel on it's own and must be attached to an adjoining parcel.


NORTH TRACT


That part of Government Lot 5, Section 27, Township 142 North, Range 31 West, Cass County, Minnesota, described as follows: Commencing at the monumented special meander corner at the northwesterly corner of said Government Lot 5 and assuming the west line of said Government Lot 5 to bear South 6 degrees 51 minutes 59 seconds West; thence South 33 degrees 28 minutes 05 seconds East 505.00 feet to a point hereinafter referred to as Point "B"; And commencing at the Southeast corner of said Government Lot 5; thence North 6 degrees 52 minutes 16 seconds East along the east line of said Government Lot 5 a distance of 156.55 feet; thence North 77 degrees 54 minutes 18 seconds West 320.95 feet to a point hereinafter referred to as Point "A"; And commencing at the Southwest comer of the Southeast Quarter of the Southwest Quarter, said Section 27; thence North 6 degrees 51 minutes 59 seconds East along the west line of said Southeast Quarter of the Southwest Quarter and the west line of said Government Lot 5 a distance of 1277.69 feet; thence North 30 degrees 58 minutes 30 seconds East 288.78 feet to the point of beginning of the tract to be herein described; thence South 76 degrees 33 minutes 03 seconds East 865.57 feet to said Point "A"; thence North 12 degrees 05 minutes 42 seconds East 133.31 feet; thence South 77 degrees 54 minutes 18 seconds East 206.59 feet to the centerline of the township road; thence North 17 degrees 20 minutes 24 seconds West along said centerline 602.05 feet to the intersection with a line bearing North 82 degrees 12 minutes 55 seconds East from said Point "B"; thence South 82 degrees 12 minutes 55 seconds West 677.26 feet to said Point "B"; thence South 30 degrees 58 minutes 30 seconds West 430.07 feet to the point of beginning.


