
CERTIFICATE OF SURVEY

PROPOSED BOUNDARY DESCRIPTIONS:

That part of the Northwest Quarter of the Northwest Quarter, Section 21, Township 136 North, Range 29 West, Cass County, Minnesota, lying northerly and westerly of the following described lines: Commencing at the Northwest corner of said Section 21; thence North 88 degrees 07 minutes 42 seconds East, assumed bearing, along the north line of said Northwest Quarter of the Northwest Quarter 664.11 feet to the point of beginning of the lines to be herein described; thence South 12 degrees 37 minutes 52 seconds West 689.54 feet to the south line of the Northwest Quarter of the Northwest Quarter, said Section; thence South 88 degrees 09 minutes 43 seconds West along said south line 490.56 feet to the west line of said Northwest Quarter of the Northwest Quarter and said described line there terminating.

Subject to an easement for ingress, egress and utility purposes over, under and across the south 66.00 feet of said Northwest Quarter of the Northwest Quarter of the Northwest Quarter, lying westerly of the following described line: Commencing at the Northwest corner of said Section 21; thence North 88 degrees 07 minutes 42 seconds East, assumed bearing, along the north line of said Northwest Quarter of the Northwest Quarter 664.11 feet to the point of beginning of the line to be herein described; thence South 12 degrees 37 minutes 52 seconds West 689.54 feet to the south line of said Northwest Quarter of the Northwest Quarter of the Northwest Quarter and said described line there terminating.


