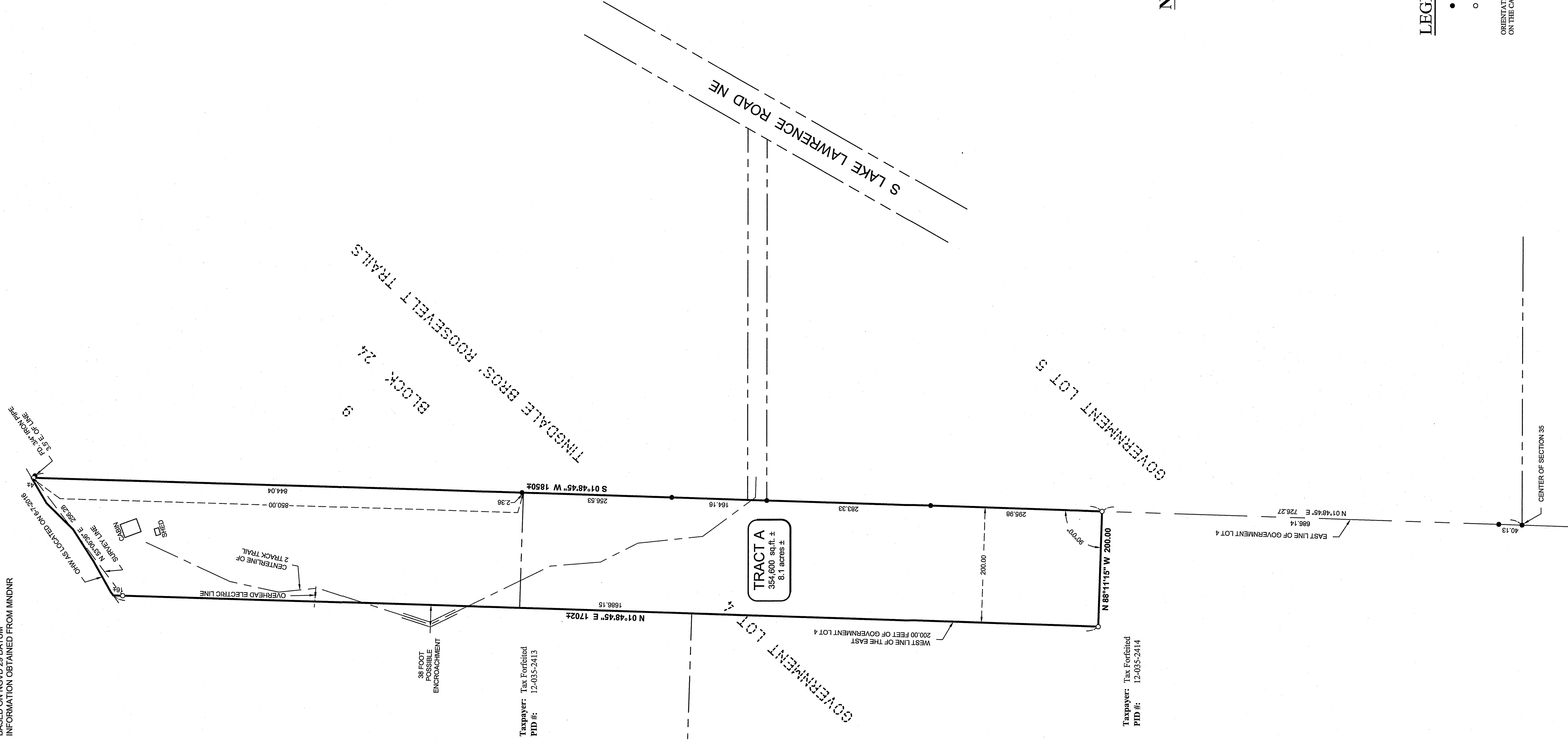

LEGAL DESCRIPTION FROM SCHEDULE A OF TITLE COMMITMENT PREPARED BY FIRST AMERICAN TITLE INSURANCE COMPANY

That part of Government Lot Four (4), of Section Thirty-five (35), Township One Hundred and Thirty-nine (139) North, Range Twenty-six (26) West of the Fifth Principal Meridian, Minnesota, according to the United States Government survey thereof, described as follows: Beginning at a point on the lake shore of Lake Lawrence intersected by the East lot line of said Government Lot 4; thence Southerly along said East lot line a distance of 850 feet, thence Westerly along a line at right angles to the said East lot line a distance of 200 feet from and parallel to the East lot line of said Government Lot 4 to the shore of Lake Lawrence, thence generally Easterly along the shore of Lake Lawrence to the point of beginning.

AND
That part of Government Lot Four (4), of Section Thirty-five (35), Township One Hundred and Thirty-nine (139) North, Range Twenty-six (26) West of the Fifth Principal Meridian, Minnesota, according to the United States Government survey thereof, described as follows: Beginning at a point on the East lot line of said Government Lot 4, measured Southerly a distance of 850 feet from the lakeshore of Lake Lawrence Lake there Southerly along said East lot line a distance of 1,000 feet, thence Westerly along a line at right angles to the said East lot line a distance of 200 feet, thence Easterly along a line parallel to the East lot line of said Government Lot 4, a distance of 1,000 feet, thence Easterly along a line at right angles to said East lot line of said Government Lot 4, a distance of 200 feet to the point of beginning.

PROPOSED BOUNDARY DESCRIPTION:

TRACT A

That part of Government Lot 4, Section 35, Township 139 North, Range 26 West, Cass County, Minnesota, described as follows: Commencing at the Center of said Section 35; thence North 01 degree 48 minutes 45 seconds East, assumed bearing, along the east line of said Government Lot 4 for a distance of 726.27 feet to the point of beginning of the tract to be herein described; thence North 88 degrees 11 minutes 15 seconds West 200.00 feet to the west line of the east 200.00 feet line of said Government Lot 4; thence North 01 degree 48 minutes 45 seconds East along said west shoreline to the intersection with said east line; thence South 01 degree 48 minutes 45 seconds West along said east line 1850 feet, more or less, to the point of beginning.

Subject to easements, restrictions and reservations of record.

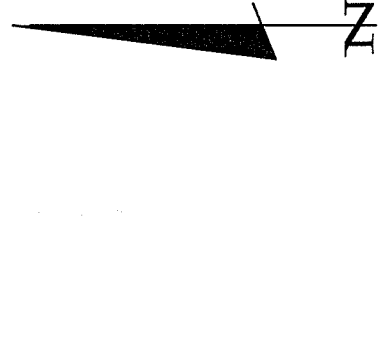

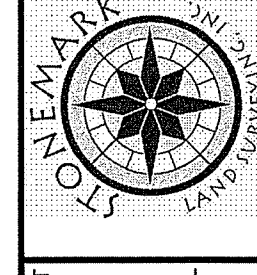
