## **PROPOSED DESCRIPTIONS:**


A 33.00 foot wide easement for ingress, egress, and utility purposes over, under, and across that part of the Southeast Quarter of the Northwest Quarter, Section 3, Township 141 North, Range 29 West, Cass County, Minnesota, the centerline of said 33.00 foot wide easement is described as follows: COMMENCING at the southeast corner of said Southeast Quarter of the Northwest Quarter; thence North 88 degrees 14 minutes 01 second West, assigned bearing, along south line thereof, 620.85 feet to a point hereinafter referred to as Point "A"; thence South 88 degrees 14 minutes 01 second East, along said south line, 172.64 feet to the point of beginning of the centerline to be herein described; thence North 39 degrees 17 minutes 14 seconds West 150.11 feet; thence North 07 degrees 19 minutes 15 seconds East 94.35 feet; thence North 15 degrees 08 minutes 34 seconds East 75.46 feet; thence northerly 61.32 feet, along a tangential curve, concave to the west, having a radius of 50.00 feet, and a central angle of 70 degrees 16 minutes 20 seconds; thence North 55 degrees 07 minutes 46 seconds West, tangent to said curve, 81.06 feet; thence North 70 degrees 35 minutes 59 seconds West 23.99 feet to the intersection with line bearing North 00 degrees 03 minutes 53 seconds East from said Point "A" and said described centerline there terminating.


