SURVEYOR'S NOTES

1. This survey was performed, and the survey map prepared, without benefit of either a title insurance commitment or an attorney's title opinion. The record boundary and easement information (if any) shown herein is based on information provided by the client. Research of documents affecting title to the property surveyed or adjoining properties has been limited to a cursory review of record information and it is recommended that all title matters affecting this property and survey be reviewed by an attorney or other title professional.
2. Only utility lines and structures observed during the course of the field survey of this site are shown on this map. The surveyor does not guarantee that there are no other utility lines and structures, active or abandoned, on or adjacent to the subject property.
3. Field work was completed on December 12th, 2017.
4. The field survey on which this map is based was performed when snow was covering all or part of the subject property. There could be improvements on the site, or encroachments onto or from the site, observable under other conditions but hidden by snow on the date of this survey.
5. Orientation of the bearing system used for this survey is based on the north line of Government Section 32, T14N, R28W, which is assumed to bear N 89°30'00"E.
6. Vertical Benchmark - Minnesota DNR Benchmark Located at public access of Wabedo Lake. Elevation=1313.3(NNGVD29).
7. Total area of parcel above Ordinary high water = 17,246 Sq. Ft.
Total Impervious area=2,210 Sq. Ft. (12.8%)

EXISTING LEGAL DESCRIPTION

(Per Document No. 313670)

TRACT C- That part of Government Lot 2, Section 32, Township 140 North, Range 28 West, described as follows: Commencing at the Northwest corner of said Lot 2; thence north 89 degrees 50 minutes east 63.30 feet along a line which is the southerly right-of-way line of County Road No. 120; thence south 79 degrees 31 minutes west 113.28 feet along said right-of-way line; thence north 69 degrees 30 minutes east 100.90 feet along a legal right-of-way line to the point of beginning of the tract to be described; thence south 62 degrees 48 minutes west 49.23 feet along said right-of-way line; thence south 20 degrees 25 minutes east 361 feet, more or less, to the shore of Wabedo Lake; thence northeasterly 50 feet, more or less, along said shore to the point of arrival which is located 23 minutes west of the point of beginning; thence north 20 degrees 21 minutes west 354 feet, more or less, to the point of beginning. Subject to and together with an easement for roadway purposes, 20 feet wide, through part of Govt Lot 2, Section 32, Township 140 North, Range 28 West, running S 62°48'00"E 49.23 feet to the point of beginning of said Lot 2; thence north 89 degrees 50 minutes east 63.30 feet along the north line of said Lot 2; thence south 0 degrees 03 minutes 30 seconds east 280.00 feet to the southerly right-of-way line of County Road No. 120; thence South 79 degrees 32 minutes west 212.28 feet along said right-of-way line to the point of arrival which is located 23 minutes west of the point of beginning; thence north 14 degrees 35 minutes east 155.70 feet; thence south 58 degrees 25 minutes west 90.36 feet; thence south 73 degrees 35 minutes west 80.14 feet; thence north 34 degrees 45 minutes west 117.45 feet; thence north 23 degrees 51 minutes west 74.52 feet to the southerly right-of-way line of said County Road No. 120 and there ending.


