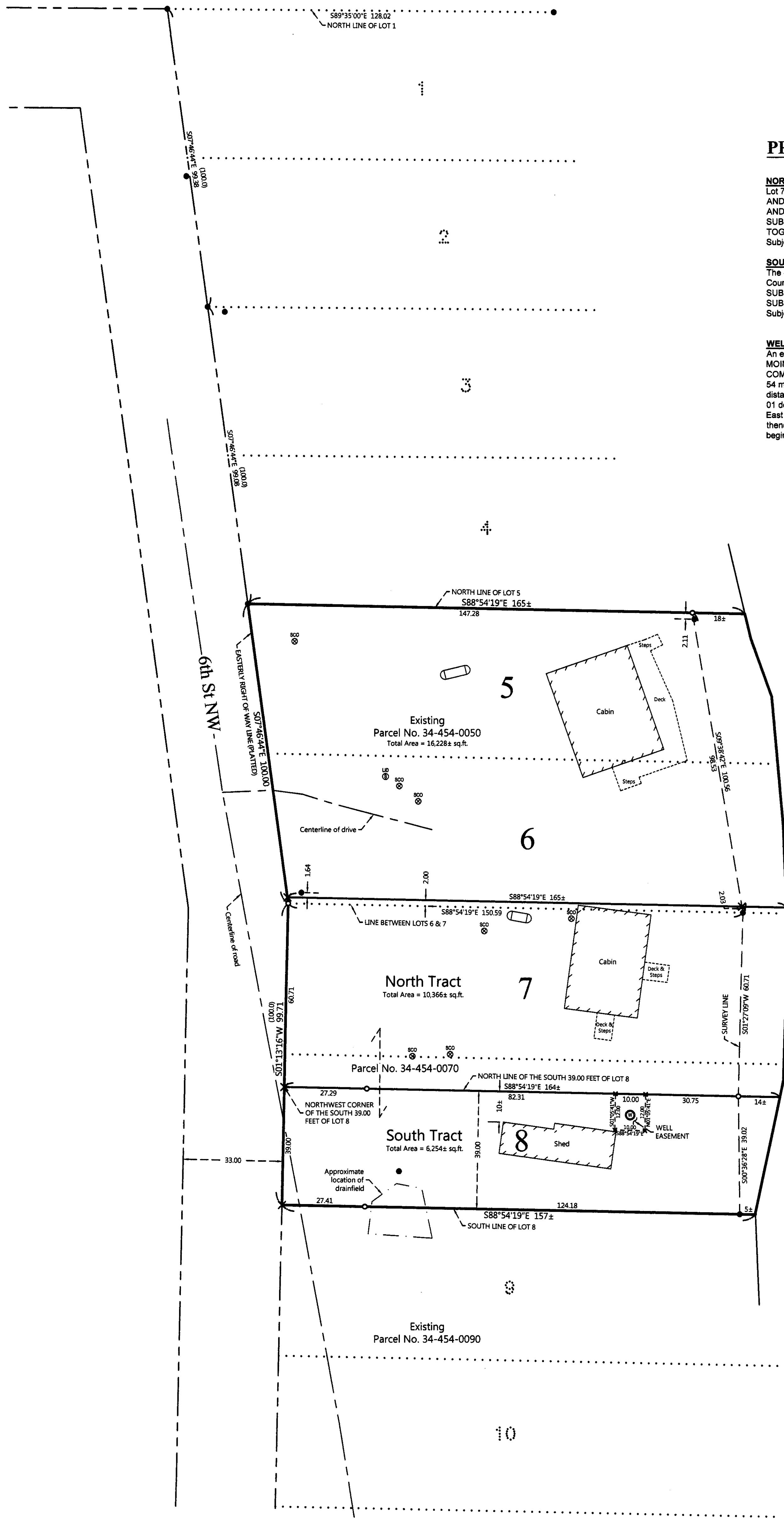


# CERTIFICATE OF SURVEY

## PROPOSED DESCRIPTIONS:

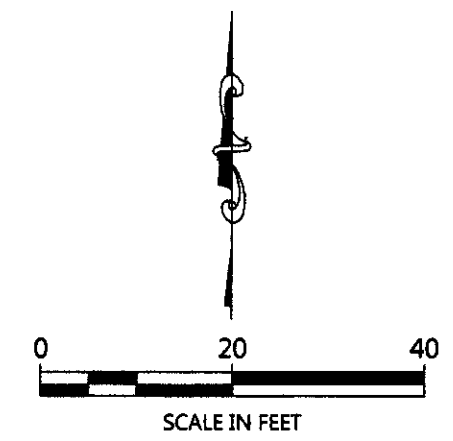
**NORTH TRACT (to be attached to existing Parcel No. 34-454-0050)**  
Lot 7, DES MOINES BEACH, according to the recorded plat thereof, Cass County, Minnesota;  
AND the South 2.00 feet of Lot 8, said DES MOINES BEACH;  
AND that part of Lot 8, said DES MOINES BEACH lying northerly of the South 39.00 feet thereof.  
SUBJECT to easements, restrictions, and reservations of record.  
TOGETHER with a Well Easement.  
Subject tract is non-conforming on it's own and must be attached to an adjacent parcel.

**SOUTH TRACT (to be attached to existing Parcel No. 34-454-0090)**  
The South 39.00 feet of Lot 8, DES MOINES BEACH, according to the recorded plat thereof, Cass County, Minnesota.  
SUBJECT to easements, restrictions, and reservations of record.  
SUBJECT to a Well Easement.  
Subject tract is non-conforming on it's own and must be attached to an adjacent parcel.

## WELL EASEMENT

An easement for inspection and maintenance of a well over, under, and across that part of Lot 8, DES MOINES BEACH, according to the recorded plat thereof, Cass County, Minnesota, described as follows: COMMENCING at the northwest corner of the South 39.00 feet of said Lot 8; thence South 88 degrees 54 minutes 19 seconds East, assigned bearing, along the north line of said South 39.00 feet, for a distance of 109.60 feet to the point of beginning of the easement to be herein described; thence South 01 degrees 05 minutes 41 seconds West 12.00 feet; thence South 88 degrees 54 minutes 19 seconds East 10.00 feet; thence North 01 degrees 05 minutes 41 seconds East 12.00 feet to said north line; thence North 88 degrees 54 minutes 19 seconds West, along said north line, 10.00 feet to the point of beginning.

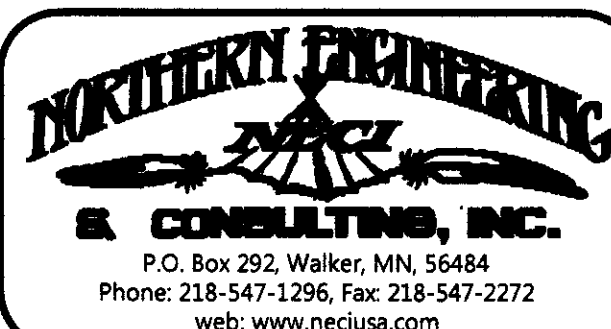
## NOTES:
