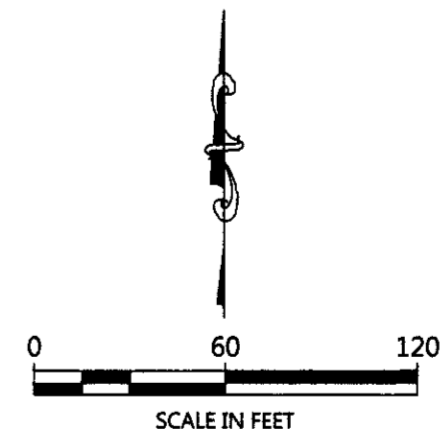

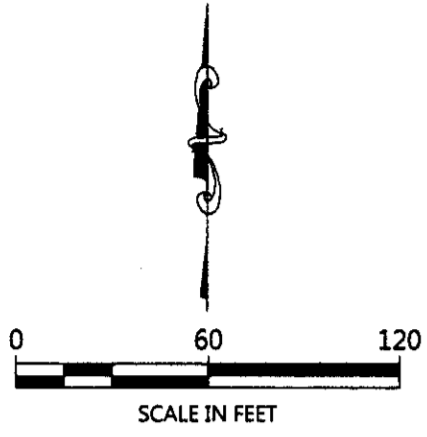

EAST - WEST QUARTER LINE, SECTION 35

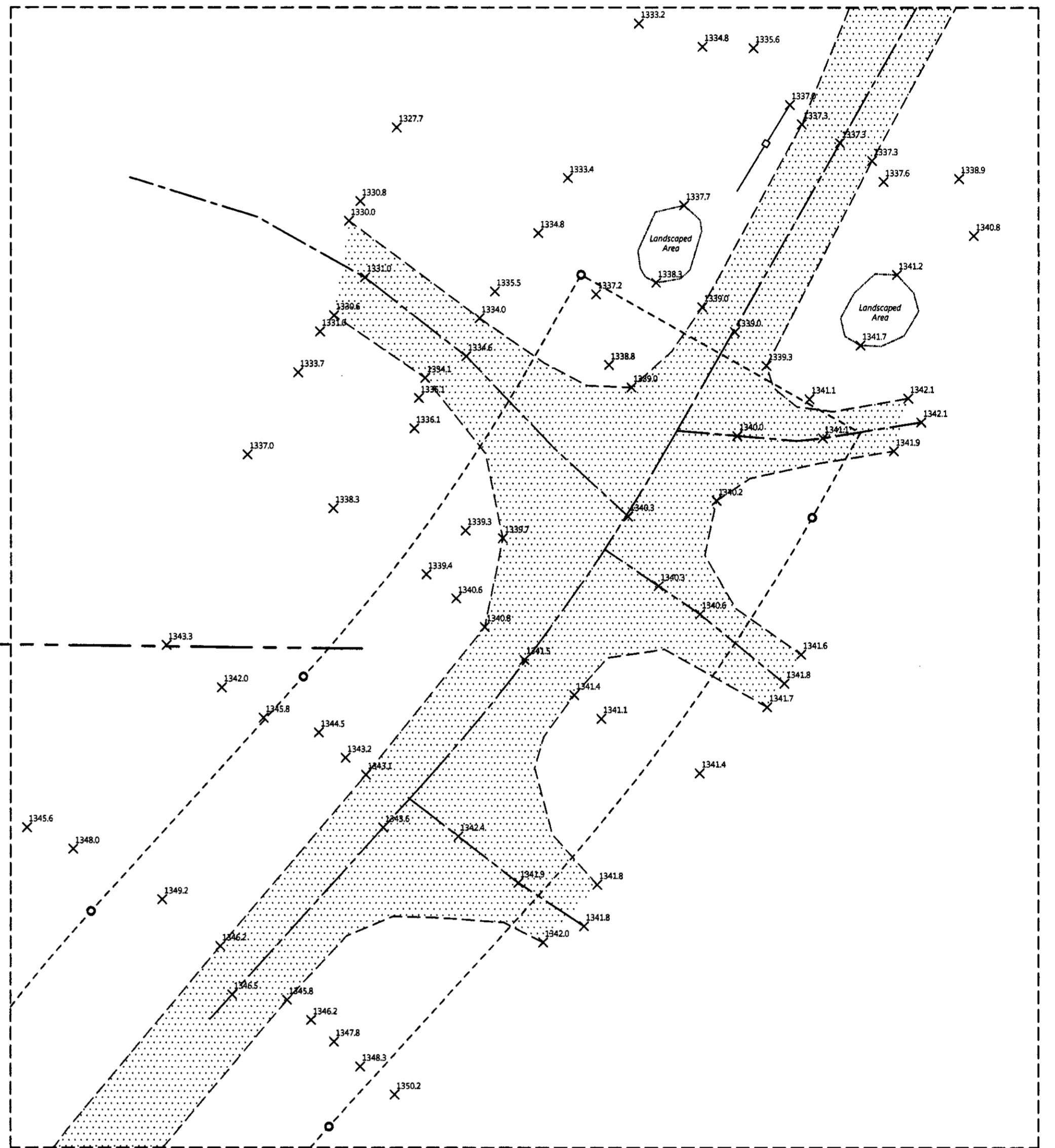
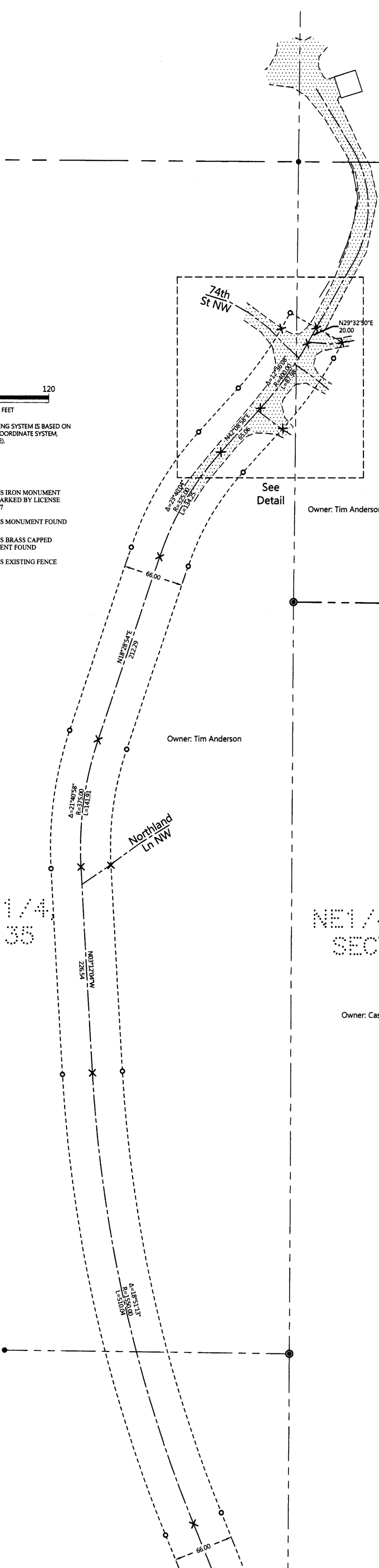

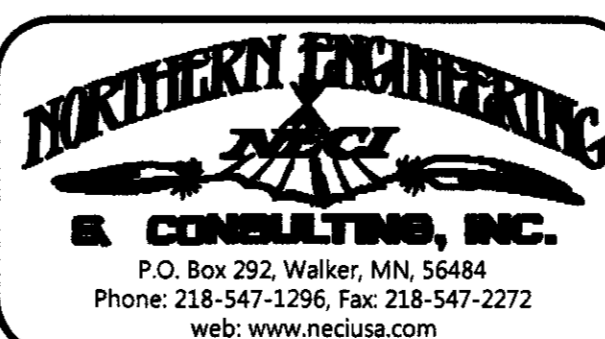
