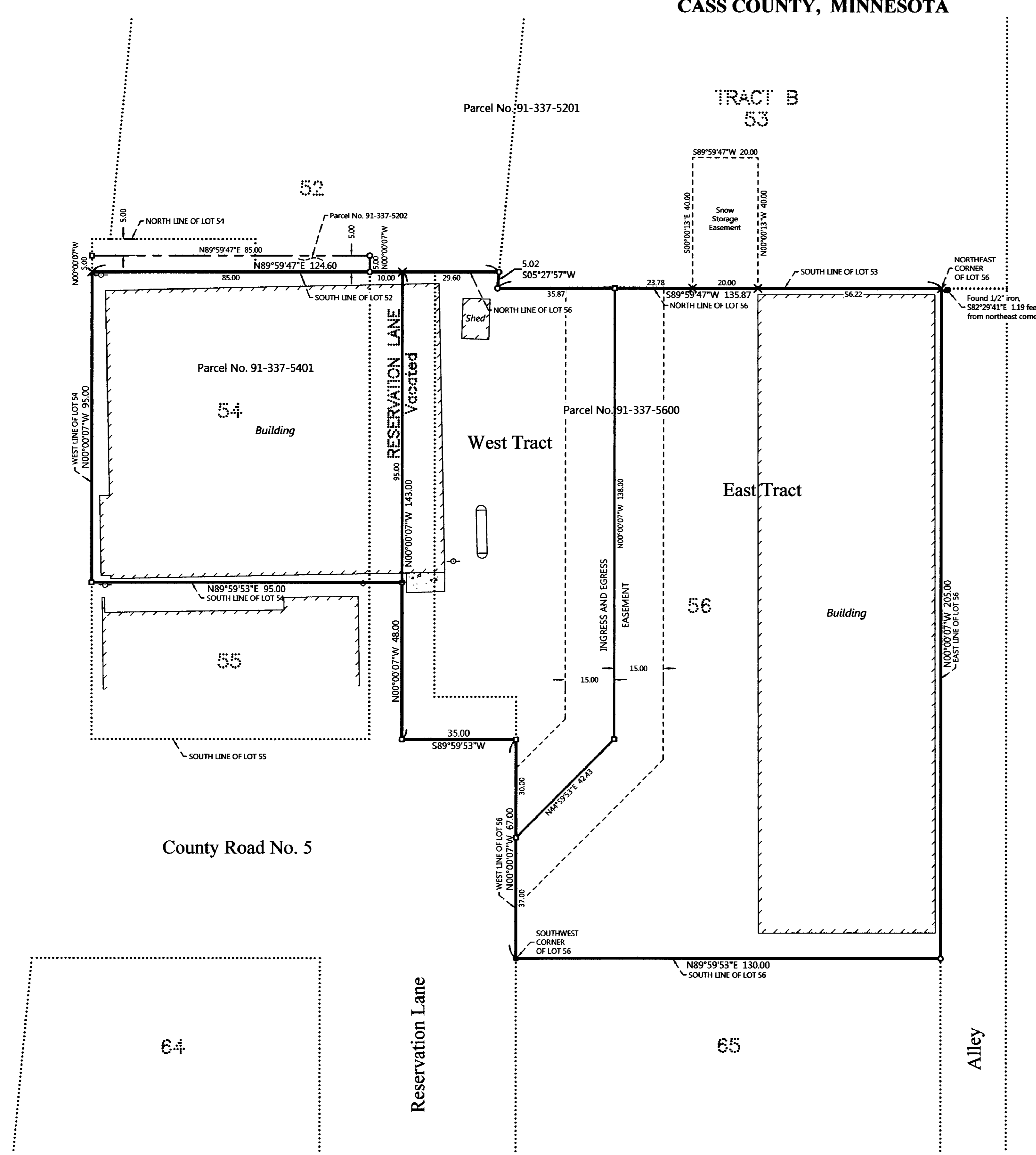

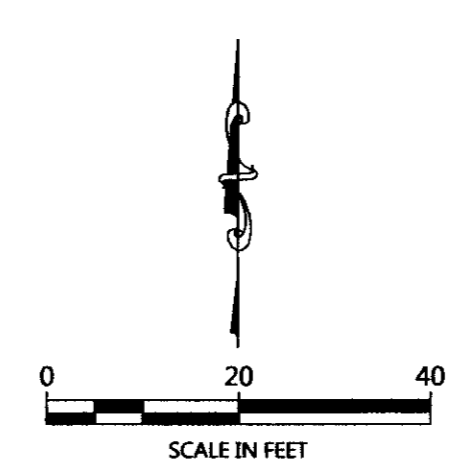
Those parts of Lot 56 and vacated Reservation Lane, AUDITORS PLAT OF LONGVILLE, according to the recorded plat on file, Cass County, Minnesota, described as follows: Commencing at the southwest corner of said Lot 56; thence North 00 degrees 00 minutes 07 seconds West, assigned bearing along the west line thereof, 37.00 feet; thence North 44 degrees 59 minutes 53 seconds East 42.43 feet, to the Point of Beginning of the tract to be herein described; thence South 44 degrees 59 minutes 53 seconds West 42.43 feet, to said west line; thence North 00 degrees 00 minutes 07 seconds West, along the west line thereof, 30.00 feet, to the intersection with the easterly extension of the south line of Lot 55, said plat; thence South 89 degrees 59 minutes 53 seconds West, along said extended south line, 35.00 feet, to the centerline of said vacated Reservation Lane; thence North 00 degrees 00 minutes 07 seconds West, along said centerline, 143.00 feet to the south line of Lot 52, said plat; thence North 89 degrees 59 minutes 47 seconds East, along last said south line and the north line of said Lot 56, a distance of 29.60 feet; thence South 05 degrees 27 minutes 57 seconds West, along last said north line 5.02 feet; thence North 89 degrees 59 minutes 47 seconds East, along said north line of Lot 56, a distance of 35.87 feet, to the intersection with a line bearing North 00 degrees 00 minutes 07 seconds West from the point of beginning; thence South 00 degrees 00 minutes 07 seconds East 138.00 feet to the point of beginning.

The sidelines of said 30.00 foot wide easement shall be prolonged or shortened to terminate on said west and north lines of Lot 56.

SNOW STORAGE EASEMENT

An easement for snow storage over and across Lot 53, AUDITORS PLAT OF LONGVILLE, according to the recorded plat on file, Cass County, Minnesota, described as follows: COMMENCING at the northeast corner of Lot 56, said plat; thence South 89 degrees 59 minutes 47 seconds West, assigned bearing, along the north line of said Lot 56, also being the south line of said Lot 53, for a distance of 56.22 feet to the point of beginning of the easement to be herein described; thence North 00 degrees 00 minutes 13 seconds West 40.00 feet; thence South 89 degrees 59 minutes 47 seconds West 20.00 feet; thence South 00 degrees 00 minutes 13 seconds East 40.00 feet to said south line; thence North 89 degrees 59 minutes 47 seconds East, along said south line, 20.00 feet to the point of beginning.

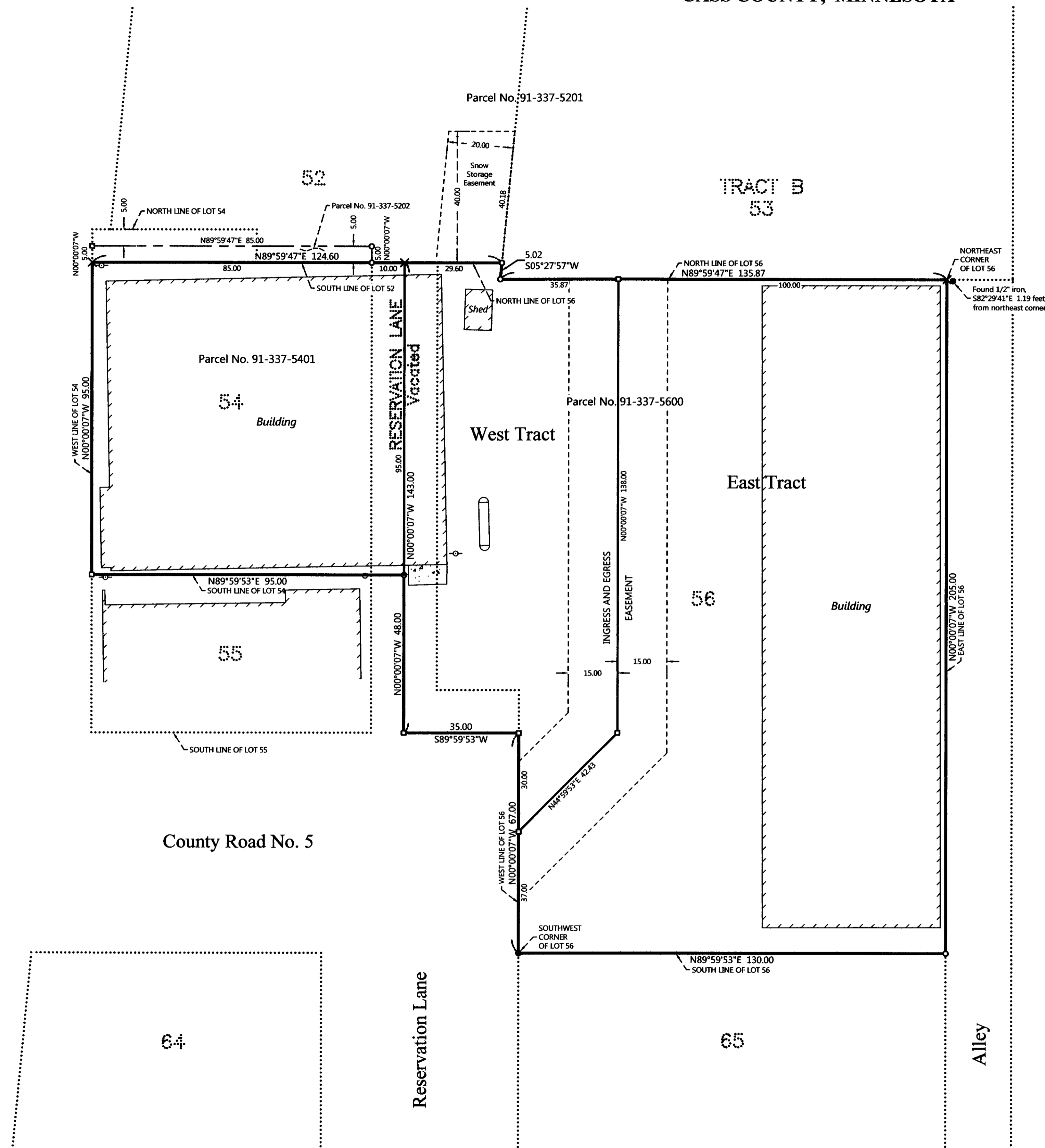

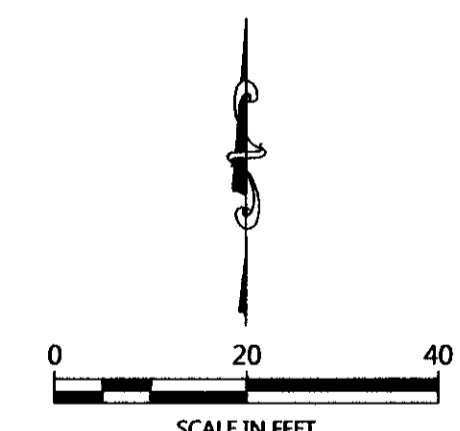
