

EXISTING DESCRIPTION "A" - (As Per Doc. No. A000631860 - Parcel No.: 14-129-1001)

The South 505.00 feet of the Northeast Quarter of the Northeast Quarter, Section 29, Township 134 North, Range 30 West, Cass County, Minnesota, lying East of the West 561.00 feet thereof and lying West of the East 200.00 feet thereof. Subject to and together with a 33.00 foot wide easement for ingress, egress, and utility purposes described as set out in Exhibit A-1 recorded as Document No. A000502777.

Said parcel contains 7.1 acres of land, more or less, and is subject to existing easements of record.




