
CERTIFICATE OF SURVEY



PROPOSED DESCRIPTION:

That part of Government Lot 5, Section 1, Township 141 North, Range 31 West, Cass County, Minnesota, described as follows: BEGINNING at the southwest corner of Government Lot 2, said Section 1; thence North 02 degrees 57 minutes 48 seconds West, assigned bearing, along the east line of said Government Lot 5, for a distance of 129.14 feet; thence South 77 degrees 04 minutes 18 seconds West 78.04 feet; thence South 67 degrees 33 minutes 03 seconds West 20.88 feet; thence South 16 degrees 29 minutes 53 seconds East 111.51 feet; thence North 87 degrees 14 minutes 49 seconds East 70.45 feet to the point of SUBJECT to easements, restrictions, and reservations of record.

Tract A is a non-conforming tract on its own and shall be attached to adjoining Parcel No. 38-001-2110.
