
CERTIFICATE OF SURVEY

PART OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER AND PART OF GOVERNMENT LOT 2, SECTION 23, TOWNSHIP 140 NORTH, RANGE 29 WEST,



PROPOSED DESCRIPTIONS:

HOUSE TRACT

That part of Government Lot 2 and that part of the Northwest Quarter of the Southeast Quarter, both in Section 23, Township 140 North, Range 29 West, Cass County, Minnesota, described as follows:
BEGINNING at the northeast corner of said Northwest Quarter of the Southeast Quarter, also being the southeast corner of said Government Lot 2; thence North 00 degrees 19 minutes 01 seconds West, assigned bearing, along the east line of said Government Lot 2, for a distance of 60.00 feet; thence North 89 degrees 12 minutes 42 seconds West 190.00 feet; thence South 80 degrees 19 minutes 01 seconds East 270.05 feet; thence South 89 degrees 12 minutes 42 seconds East 188.89 feet to the east line of said Northwest Quarter of the Southeast Quarter, thence North 00 degrees 31 minutes 51 seconds East, along last described east line, 210.01 feet to the point of beginning.
SUBJECT to easements, restrictions, and reservations of record.
SUBJECT to Knotty Knotl Drive NW right of way.

REMAINDER TRACT
That part of Government Lot 2 and that part of the Northwest Quarter of the Southeast Quarter, both in Section 23, Township 140 North, Range 29 West, Cass County, Minnesota, described as follows:
COMMENCING at the northwest corner of said Northwest Quarter of the Southeast Quarter, thence South 89 degrees 12 minutes 42 seconds East, assigned bearing, along the north line of said Northwest Quarter of the Southeast Quarter, 570.10 feet to a point hereinafter referred to as Point *A*; thence South 89 degrees 12 minutes 42 seconds East, assigned bearing, along the north line of said Northwest Quarter of the Southeast Quarter, 710.10 feet to a point hereinafter referred to as Point *A*; thence COMMENCING at the northeast corner of said Northwest Quarter of the Southeast Quarter, also being the southeast corner of said Government Lot 2; thence North 00 degrees 19 minutes 01 seconds West, assigned bearing, along the east line of said Government Lot 2, for a distance of 60.00 feet; thence North 89 degrees 12 minutes 42 seconds West 190,00 feet; thence South 00 degrees 19 minutes 01 seconds Seast 270.05 feet to the point of beginning of the tract to be herein described; thence North 00 degree 19 minutes 01 seconds West 101.24 feet; thence South 84 degrees 24 minutes 49 seconds West 39.97 feet; thence westerly 198.30 feet, along a tangential curve, concave to the north, having a radius of 621.59 feet, and a central angle of 18 degrees 16 minutes 43 seconds; thence North 77 degrees 18 minutes 28 seconds West, tangent to said curve, 183.00 feet; thence northwesterly 99.94 feet, along a tangential curve, concave to the northeast, having a radius of 1171.52 feet, and a central angle of 04 degrees 53 minutes 16 seconds: thence North 72 degrees 25 minutes 12 seconds West, tangent to last described curve, 69.12 feet; thence northwesterly 77.85 feet, along a tangential curve, concave to the northeast, having a radius of 714.95 feet, and a central angle of 04 degrees 53 minutes 18 seconds: thence North 70 degrees 17 minutes 34 seconds West from said Point *A*; thence South 00 degrees 17 minutes 34 seconds West from said Point *A*; thence South 00 degrees 17 minutes 34 seconds East 773.72 feet; thence North 98 degrees 18 minutes 51 seconds East, along said east line, 541.40 feet to the intersection with a line bearing South 90 degrees 12 minutes 51 seconds East, along said east line, 541.40 feet to the intersection with a line bearing South 90 degrees 12 minutes 51 seconds East prom the point of beginning; thence N point of beginning; thence North 89 degrees 12 minutes 42 seconds West to the point of beginning. SUBJECT to easements, restrictions, and reservations of record. SUBJECT to Knotty Knoll Drive NW right of way.
