

CERTIFICATE OF SURVEY

LEGAL DESCRIPTIONS:

PARCEL A: That part of Government Lot Two (2) of Section Seventeen (17), Township One Hundred Forty-five (145) North, Range Thirty-one (31) West, Cass County Minnesota, described as follows:
