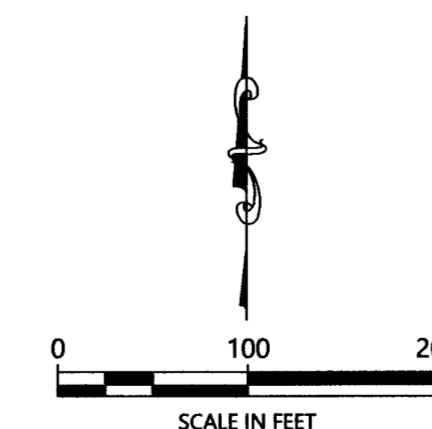

33.00 Foot Easement

A 33.00 foot wide easement for ingress and egress purposes over, under, and across that part of the Northwest Quarter of the Southwest Quarter, Section 27, Township 141 North, Range 31 West, Cass County, Minnesota the centerline of which is described as follows: COMMENCING at the northwest corner of said Northwest Quarter of the Southwest Quarter; thence North 89 degrees 47 minutes 39 seconds East, assigned bearing, along the north line thereof, 1278.00 feet to the northeast corner of said Northwest Quarter of the Southwest Quarter; thence South 03 degrees 09 minutes 57 seconds West, along the east line of said Northwest Quarter of the Southwest Quarter, 185.69 feet to the Point of Beginning of said easement to be herein described; thence South 46 degrees 45 minutes 32 seconds West 488.52 feet; thence South 53 degrees 15 minutes 48 seconds West 35.58 feet and said centerline there terminating. The sidelines of said easement shall be prolonged or shortened to terminate on said east line and lines that bear South 29 degrees 24 minutes 15 seconds East and North 29 degrees 24 minutes 15 seconds West from the point of termination.
