Commencing at the 1/4 comer common to Section 23 & 24 marked with a brass capped iron monument; thence North 01 degrees 23 minutes 55 seconds West along the section line a distance of 500 feet to the point of beginning marked with a 1/2" x 24" re-bar; thence continuing along the section line North 01 degrees 23 minutes 55 seconds West a distance of 319.00 feet to a point marked with a 1/2 "x 24" re-bar; thence North 89 degrees 04 minutes 48 seconds East a distance of 585.06 feet to a point of the shoreline of Knights Lake marked with a 1/2" x 24" re-bar; thence South 25 degrees 00 minutes 00 seconds East along the shoreline a distance of 100.00 feet, marked with a 1/2" x 24" re-bar; thence North 60 degrees 00 minutes 00 seconds East along the shoreline a distance of 223.71 feet, marked with a 1/2" x 24" re-bar; thence South 17 degrees 38 minutes 34 seconds West a distance of 352.71 feet to a point marked with a 1/2" x 24" re-bar; thence South 89 degrees 04 minutes 48 seconds West a distance of 707.55 feet to the point of beginning: together with a 66 foot road and utility easement along the west edge of said tract.



Commencing at the 1/4 comer common to Section 23 & 24 marked with a brass capped iron monument; thence North 01 degrees 23 minutes 55 seconds West along the section line a distance of 500.00 feet; thence North 89 degrees 04 minutes 48 seconds East, on a line here in now described as Line "A", then along said Line "A", a distance of 707.55 feet; thence North 17 degrees 38 minutes 34 seconds East 232.57 feet to the point beginning of said centerline; thence South 78 degrees 55 minutes 46 seconds West 28.08 feet; thence South 70 degrees 07 minutes 24 seconds West 45.69 feet; thence South 76 degrees 32 minutes 32 seconds West 42.09 feet; thence westerly 37.99 feet, along a tangential curve, concave to the North, with a central angle of 23 degrees 09 minutes 23 seconds, and a radius of 94.00 feet; thence North 80 degrees 18 minutes 05 seconds West, tangent with curve, a distance of 23.57 feet; thence southwesterly 53.31 feet, along a tangential curve, concave to the South, with a central angle of 43 degrees 37 minutes 58 seconds, and a radius of 70.00 feet; thence South 56 degrees 03 minutes 57 seconds West, tangent with curve, a distance of 33.29 feet; thence South 50 degrees 17 minutes 51 seconds West 91.96 feet; thence southerly 53.82 feet, along a tangential curve, concave to the southeast, with a central angle of 45 degrees 20 minutes 50 seconds, and a radius of 68.00 feet; thence South 04 degrees 57 minutes 01 seconds West, tangent with curve, a distance of 11.08 feet; thence southwesterly 77.89 feet, along a tangential curve, concave to the northwest, with a central angle of 75 degrees 38 minutes 40 seconds, and a radius of 59.00 feet; thence South 80 degrees 35 minutes 41 seconds West, tangent with curve, a distance of 0.10 feet more or less, to intersect said Line "A", then said centerline
