## CERTIFICATE OF LOCATION OF GOVERNMENT CORNER

For the East Quarter Corner of Section 18, Township 143 North, Range 26 West of the 5th Principal Meridian, STATE OF MINNESOTA, County of Cass.

On-May-13, 1986, to mark this corner position, we set a 2.5 inch (outside diameter) by 60 inch long galvanized iron pipe, with a polystyrene base containing an embedded magnetized pellet, and topped with a 3 inch diameter brass tablet, up 18 inches and stamped as shown in the sketch.

STATEMENT OF EVIDENCE: For the East Quarter Corner of Section 18; Township 143 North, Range 26 West of the 5th Principal Meridian.

This-cerner position-was originally-established on August 30, 1872, by Eli W. Griffin, Deputy Surveyor, under contract to the General Land Office, now the Bureau of Land Management (BLM). The record of this survey is on file in the Office of the Secretary of State, St. Paul, Minnesota, and indicates that a wood post-was-set-to-mark-this corner position. This monumented position was referenced by: a 5 inch-diameter Fir that bears NORTH-46 degrees EAST, a distance of 15 links-(9.90 feet); and a 6 inch-diameter Birch that bears SOUTH 69 degrees WEST, a distance of 6 links (3.96 feet).

I was unable to find any intervening record of subsequent visitations to this corner-position and-on-February 20,-1986, I-talked to-Albert Hare, owner-of-the-East One-half of the Southeast Quarter of Section 18 and the Southwest Quarter of the Southwest Quarter of Section 17. We discussed the fences in the vicinity and he-told me that his father-had built the fences shortly after aquiring the land in the 1940s. He also told me that there had been a white post with a rounded top in the vicinity-of-the-East Quarter Corner-of-Section 18 and that is what his father had-used-as-a-terminous-point-for his-fence. - We searched the area near this fence corner and recovered a very rotted piece of cedar-but there were no discernable marks on-the piece-we-found... During the 1930s the Civilian Conservation Corps (CGC) used to set a cedar post, having a sloping face with plantation identification, near corners of plantations. Since no record of a CCC survey could be found and Mr. Hare's description of the post, it is logical to surmise that Mr. Hare's father found and used one of these plantation markers. Based on our measurments it appears that who ever set the post refered to by Mr. Hare chained east 2640 feet from the occupation line at the South Quarter Corner of Section 18 and then northerly 2640 and placed the referenced post. This would not constitute proper survey methods because of other historical evidence of this corner-position that has been of public record in the Cass County Courthouse since 1913 and 1922.

Without the record of the procedures used by the CCCs to establish the plantation earner I cannot accept the fence corner as evidence of this corner position. We can only speculate as to what transpired and historical evidence of procedures used by the CCCs to establish corners show a distinct probability of not bothering to look for or reestablish corners using proper prodedures because they were not surveyors nor had they received the proper training to make the kinds of decisions require for surveying. Had they measured the entire East Line of Section 18 they would have reestablished this corner position using lost methods as I have chosen to do. Since I feel that the CCC's did not properly establish the poition for the plantation corner. I choose to use the lost position, determined using single proportionate methods, and monumeted as shown on the front of this document.
