CERTIFICATE OF LOCATION OF GOVERNMENT CORNER

For the Southeast Corner of Section 20, Township 143 North, Range 26 West of the 5th Principal Meridian, STATE OF MINNESOTA, County of Cass.

On April 10, 1986, to mark this corner position, we set a 2.5 inch (outside diameter) by 60 inch long galvanized iron pipe, with a polystyrene base containing an embedded magnetized pellet, and topped with a 3 inch diameter brass tablet, up 18 inches and stamped as shown in the sketch.

S-15°-W, 91.99 feet to a hole punched in the north end of a 15 inch corrugated metal pipe.

S 68° E, 48.98 feet to a 16d nail in the northerly face of a 4.7 inch Ash, single blazed and scribed "BT".

All bearing trees are marked with red enamel, a USFS 54-3 "BEARING TREE TAG", and a 60d spike driven vertically into the base of the baseblaze.

Statement of evidence relative to this corner position is on the back.

STATEMENT OF EVIDENCE: For the Southeast-Corner of Section 20, Township 143
North, Range 26 West of the 5th Principal Meridian.

This corner position-was originally established on August 27, 1872, by Eli W. Griffin, Deputy Surveyor, under contract to the General Land Office, now the Bureau of Land Management (BLM). The record of this survey is on file in the Office-of-the Secretary of State, St.-Paul, Minnesota, and indicates that Mr. Griffin-set a wood post to mark-this corner position. This corner position was referenced by: a 12 inch diameter Birch that bears NORTH 70 degrees WEST, a distance of 14-links-(9.24 feet); a 5 inch diameter Birch that bears NORTH 7 degrees WEST, a distance of 30 links (19.80 feet); a 5 inch diameter Maple that bears NORTH 38 degrees-EAST, a distance of 30 links (19.80 feet); and an 8 inch diameter Maple that bears SOUTH 72 degrees EAST, a distance of 10 links (6.60 feet.

In the-Office of Walt Curo, -R.L.S., Hackensack, Minnesota, we found the record of a survey-by-E.-B.-Horst dated 1916.—This record, in field book number 68, page 28, indicates that Mr. Horst found both original Birch bearing trees "plainly marked" in the Southwest and Northwest quadrants from which he set a large Cedar post-to mark the corner position. He then established as references: a 6 inch diameter Maple that bears NORTH 88 degrees EAST, a distance of 39.0 feet; a 7 inch diameter White Pine that bears NORTH 57 degrees WEST, a distance of 30.5 feet; a 7 inch diameter Maple that bears SOUTH 87 degrees WEST, a distance of 39.0 feet; and a 6 inch diameter Maple that bears SOUTH 26 degrees EAST, a distance of 38.5 feet.

Recorded on page-150 of the-Cass County Surveyor's Record Book C in the County Recorder's Office-is-a survey by James H. Flynn dated August 19, 1918. This record indicates that Mr. Flynn set a new iron monument from the two recovered original bearing trees in the Southwest and Northwest Quadrants. The record further indicates that Mr. Flynn established the following as references: a 6 inch diameter Sugar Maple that bears NORTH 88 degrees 45 minutes EAST, a distance of 29 feet; and an 8 inch diameter Fir that bears NORTH 62 WEST, a distance of 30.25 feet.

Our search for physical evidence of this corner position only revealed an old Civilian Conservation Corps (CCC) notched cedar post with a very rusted and unreadable metal tag attached. I reestablished this corner position, as monumented and shown on the front of this document, using other recovered corners and the bearings and distances from Mr. Flynn's 1918 survey record. This reestablished position falls 23 feet westerly of the recovered CCC post.
