- 1870 Wood post was set for corner.
- 1962 Minnesota Power and Light Company set 1" rebar 5280' west of Dean M. Anderson pipe at the northeast corner of Section 29 and made two bearing trees. Information form MP&L Gull River Flowage 1962 subdivision plat for Section 19-133-29, dated 11/26/62 and signed by Hubbel Carpenter, Chief Engineer.
- 1971 Dean M. Anderson found 1.25" rebar 1'± south of centerline of road
- 1977 Dean M. Anderson subdivided Section 19. He recovered MP&L evidece. It was determined that 1971 position was not corner by MP&L.
