- 1915 County Survey Record Book "B", page 464 shows a survey by N.D. Gorman. He found the stump of the original government bearing tree and found an iron monument previously established by County Surveyor John Curo who established the position by proportional measurement.
- 1974 Don Coulter, RLS#5852, found an iron monument in place.
- A Landecker and Associates, Inc. survey crew found a 1 inch iron pipe with cap down 12 inches in swamp and accepts the found monument as a perpetuation of the Quarter Corner position from which the following accessories: A steel fence post, East 20.0 feet; A steel fence post, West 20.0 feet.
