



1912 – John Curo pulled Iron Bolt set by Moulster from old Gov't B.T.'s, Curo Set a 4"x36" I.M. in Concrete. County Survey Record Book A, Pg. 439–443.

1999 – C.C.S.O. found in place Mag P.K. 1 foot west of centerline of County Road 18, flush with bit.

Aug. 2000 – C.C.S.O. from ties reset a Mag Nail post.

Dec. 2002 – Jim Kramer License No. 23668 Certificate of Survey shows Monument found.
