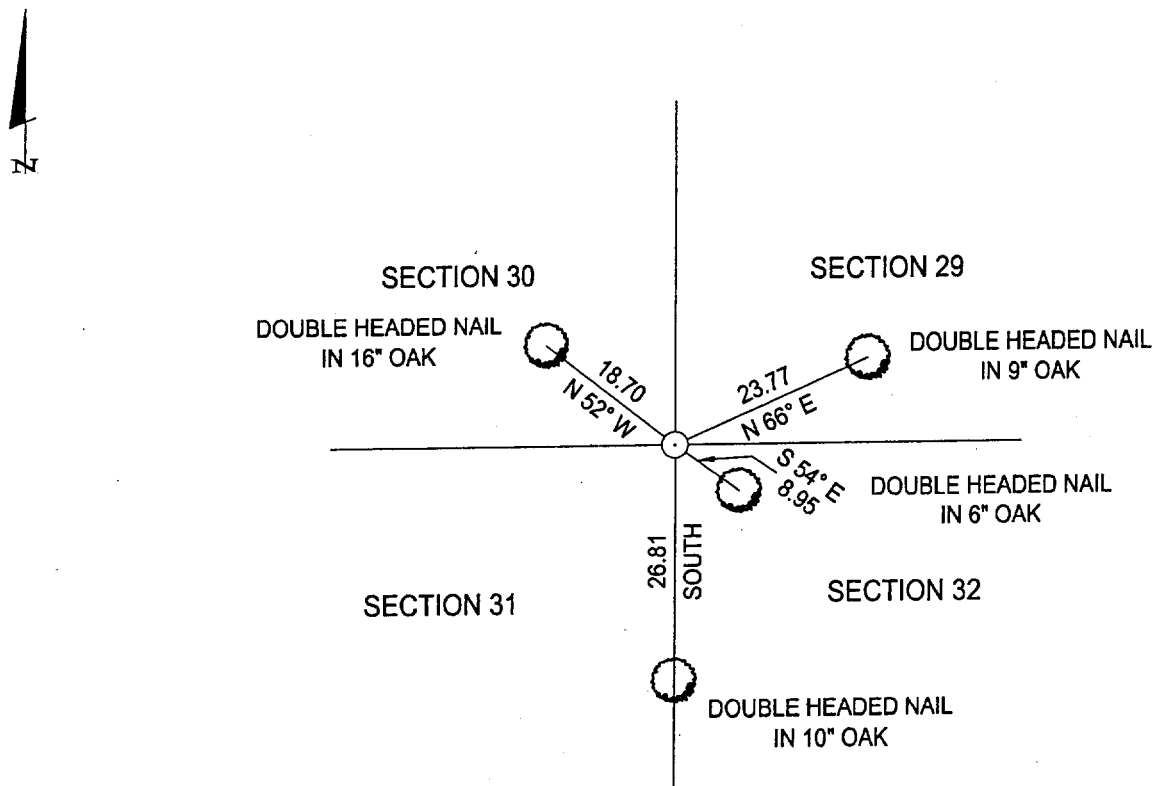

STATEMENT OF EVIDENCE

Index No. V - 5

Northeast Corner, Section 31, Township 140
North, Range 31 West, Fifth Principal
Meridian

- 1870 Walker & Wright, U.S. Deputy Surveyors, originally established this corner position while surveying the interior subdivisional lines of Township 140 North, Range 31 West. A wood post was set to mark the corner position with the following witnesses: A 10 inch White Oak, South 16 degrees East, 50 links; A 12 inch White Oak, South 23 ½ degrees West, 47 links; A 14 inch White Oak, North 5 ½ degrees East, 51 links.
- 1905 July, a Township Road order shows no survey.
- 1037 April, a Township Road order shows no survey.
- 2006 June 6th, a Landecker & Associates, Inc. survey crew, after searching for corner evidence and finding no bearing trees, set a ¾ inch iron pipe at the obliterated position based on road centerline to the North and West with the following accessories: A 9 inch Oak, North 66 degrees East, 23.77 feet; A 6 inch Oak, South 54 degrees East, 8.95 feet; A 10 inch Oak, South 26.81 feet; A 16 inch Oak, North 52 degrees West, 18.70 feet.
