

Statement of Evidence:**North Quarter corner of Section 5, Township 135 North, Range 30 West**

Oct. 1870 R. Cronk, GLO Deputy Surveyor set a wood post for the original corner and referenced it as follows:

8" W. Birch N31°E 28 links (18.48 feet)
7" W. Pine S66°W 10 links (6.60 feet)

June 1914 Township Road Order shows no survey.

July 2005 Jarrett Leas, LS 42619, while surveying in the NE 1/4 of Section 32, set a 1/2" iron pipe capped No. 42619, (KLD Project No. ACKEM0501)

Nov. 2010 Craig E. Johnson, LS, CFedS, 44530, while surveying in Section 32, found Leas's 1/2" pipe capped 42619. Johnson measured 2641.67 feet to an iron spike at the SE corner of Section 32 and 2641.28 feet to a 1/2" iron pipe capped No. 11865 at the SW corner of said Section 32. Johnson accepted Leas's 1/2 pipe as the corner and set reference ties as depicted on the face of this certificate.
