

Statement of Evidence:**East Quarter Corner of Section 25, Township 135 North, Range 31 West**

Oct. 1869 T.B. Walker GLO Deputy Surveyor set a wood post for the original corner and referenced it as follows:

6" Tam. N07°E 28 links (18.48 feet)

6" Tam. S75°W 39 links (25.74 feet)

Aug. 2001 John Walker, Minnesota D.N.R. did a survey in section 25, T135, R31, Certificate of survey WMA01198.00.00.01 on file at the CCSO. The DNR survey shows the E1/4 corner of Section 25 was not set and falls in a pond, the DNR used a calculated position on line and midway between the NE and SE corners of Section 25. The DNR set several irons on the east line of Section 25.

Nov. 2010 Craig E. Johnson, LS, CFedS, a search of the area found no evidence of the corner or it's accessories. The 1/4 corner position falls in a pond, Johnson found one of the DNR monuments on the east line of Section 25 and used it as a reference corner to the 1/4 as depicted on the face of this certificate. The DNR calculated position for the East 1/4 corner of Section 25 was accepted as the corner.
